

ORDERS FREE PASSES HERE UTILITIES COMMISSION HEARS PLEA FOR NEW TRANSFER POINTS.

Free intercompany transfers, at seven of the intersections of the lines of the Capital Traction Company and the Washington Railway and Electric Company were ordered yesterday by the Public Utilities Commission.

Small Loss to Companies. The proposed plan is framed with the special intention of relieving the situation in regard to yard employees. The transfer points fixed in the northeast section are expected to enable the employees of the yard to reach the government housing projects, which are being constructed for them, without the payment of an increased fare.

It was brought out at the hearing that the granting of transfers at these points would be the result of only a small loss to the companies. Edward A. Roberts, assistant to John A. Beeler, traffic expert, testified before the commission that the annual loss to each company would be about \$5,000, with an additional loss to the Washington Railway and Electric Company of about \$800 due to the Brightwood communication tickets.

A petition asking for the granting of further intercompany transfers was presented to the commission by James L. Wilmet, acting for the employees of the Bureau of Engraving and Printing. The petition asks for the transfers at Fourteenth street and Pennsylvania avenue, Twelfth street and Pennsylvania avenue, Fourteenth and H streets, and Seventh and G streets.

In the petition, which is signed by representatives of the various organizations of the bureau, it is pointed out that the granting of transfers between the companies at the points suggested would tend to relieve the traffic congestion at these points. It is also claimed that it would enable the 8,000 employees of the bureau to reach their work on time, thereby adding to the efficiency of the organization.

Short Trip Unjust. At present there is in effect a system of 2-cent transfers from Fourteenth street and Pennsylvania avenue. The petition holds that such a charge is unjust for such a short trip as the one to the bureau.

The commission agreed to hear further discussion of this matter. It is probable that a further hearing will be allowed at the same time as the companies are to be heard on the transfer points which have been selected.

FOOD LICENSE SYSTEM EXTENDED TO STORAGE

Extension of the Federal Food Administration's licensing system over manufacturers, dealers and stores of foods not touched by license up to this time was announced yesterday, in a proclamation issued in a proceeding headed by the President's War Industries Board, in the enforcement of this requirement.

To get more complete control over the glycerin industry, animal and vegetable fats, all concerns connected with the business of importing, manufacturing, or distributing any of the materials which may be used in products of glycerin must take out licenses.

Likewise, all millers of corn, oats, barley, or rice, no matter how small their output, must take out licenses, and also importers, manufacturers and distributors of sausage casings.

WORKMEN SEEK REDRESS. Newark Employees Ask Labor Board for Wage Increase.

Forty thousand employees of factories in and about Newark, N. J., yesterday appealed to the National War Labor Board for redress against their employers. They are machinists, tool makers and specialists and their helpers.

They ask for an increase of wages and adjustments with other war workers in each class, as follows: Tool makers, 5 cents; machinists, 75 cents; specialists, 6 cents; and helpers, 50 cents. The increase here is no one's business, but it is the duty of the War Labor Board to see that the right of the man is being done.

JEWELRY STOLEN AS POLICE STEER CROWDS

Burglars Take Advantage of Opportunity Peace Demonstration. While Mrs. Harry R. Bunnill, of apartment 5 on the first floor of 1430 Rhode Island avenue northwest, sat at the bedside of her invalid husband, burglars last night entered the apartment through a side window and committed one of the most daring and well-timed burglaries ever committed in this city.

The police are confident the burglar or burglars making a sound that would betray their presence. The theft occurred about 8:30 when every available policeman was detailed to keep order on Pennsylvania avenue where nearly 250,000 people paraded.

An inventory of the remaining contents of the dresser revealed that several large diamonds set in platinum and several valuable watches, brooches and other articles of jewelry were missing. Detective Vermillion has been assigned to the case.

COAL PRICES ADVANCE TO COVER WAGE RAISE

Fuel Administration Announces Increase Averaging 74c Ton. New prices on anthracite coal to absorb the recent increase in anthracite wages were announced by the Fuel Administration yesterday. At the same time special orders were issued to guard against an increase in price to the public on any coal of the grades affected, which had been mined previous to the wage increase. All the penalty of the Lever act will be invoked against profiteers who raise prices on coal whose cost of production was not affected by the wage increase.

The new prices are about 70.5 per cent of the total anthracite production. The new schedule carries forward without change the existing differential between the large companies and the individual operators in favor of the latter, and is as follows: White ash grade: Broken, \$5.95 and \$6.70; egg, \$5.85 and \$6.40; stove, \$6.30 and \$7.15; nut, \$6.20 and \$6.55; pea, \$4.30 and \$5.15. Red ash grade: Broken, \$6.15 and \$6.90; egg, \$6.45 and \$6.30; stove, \$6.70 and \$7.65; nut, \$6.70 and \$7.45; pea, \$5.15 and \$5.90. Existing prices were continued on sizes where no changes are announced. They are: Buckwheat, \$2.40 and \$4.15; rice, \$2.90; barley, \$2.65, and screenings, \$1.50. American ports in France, in one month, handled 37,648 tons of armaments, a daily average of 25,588 tons.

Big Increase in Coal Output Despite Plague

A remarkable increase in coal production was made in October in the Pochontas and Tug River districts of West Virginia, according to a telegram to the United States Fuel Administration from the production manager in those districts. This message pronounced the October production the greatest in the calendar year, the figures being 2,961,242 tons. Of this, 1,646,000 tons were shipped, and the remainder, 1,315,242 tons, were consumed locally. Coal output amounted to 20,000 tons. The increase exceeded by 6,000 tons the production in any previous month, and was effected despite the fact that influenza incapacitated about 2,100 men for more than half of the month.
