Supreme Court, In Banco. BEFORE ALLEN, C. J., HARTWELL AND WIDEMANN, J. J. Robert Sterling, Minister of Finance vs. H. R. Hollister.

It appears that in August 1872 a quantity of tobacco was purchased in New York by Hollister & Co. and dispatched to Honolulu...

If a man dispatches goods from New York to Honolulu, via San Francisco by Rail Road, there seems to be no good reason why duties should be imposed on the freight in the one case, more than in the other.

But it is said that he has made his election of a port of export, and should submit to all the charges made upon the goods prior to their arrival at that port.

The law does not impose it in terms, and it is a new question, arising from the great extent of Rail Road transportation.

It would seem to be unwise to discriminate against railroad transportation. The Statutes refer merely to the place of export, and to cost and charges.
