**Daily Bulletin**

MONDAY, MARCH 9, 1891.

Interesting editorial comments have been unavoidably crowded out today.

Complaints have been made that persons unknown are cutting the tops from the iron pine trees in Kapiolani Park. A dozen or more fine tops of trees from six to twelve feet high were sent to the Bulletin office this morning, which had been cut by unscrupulous visitors between last Saturday afternoon and this morning, on the main road near the residence of Mr. J. B. Castle. If it has come to this, mounted police should be appointed to patrol the park on holidays.

**REMEMBERING THE COMRADE.**

Mr. Harry Griffin, late quartermaster of the S. S. Australia, died a year ago yesterday, while the steamer was off the harbor. He was buried in the Catholic Cemetery. Yesterday the officers and crew of the Australia turned out in company to pay respect to their departed comrade. The grave was decorated with all sorts of flowers, in the shape of anchors, monograms, etc. Nothing is to be seen of the grave but a whole mass and profusion of flowers. A photograph of the decorated grave was taken, to be sent to the dead sailor's mother in Canada.

Advises received by the Paris Gazette from Buenos Ayres are that the Government troops have revolted in the province of Corrientes and have secured the Governor's palace. In consequence of this uprising, a state of siege has been declared throughout the province. President Pellegrini has ordered that the most vigorous measures be taken to suppress the outbreak.

**THE SUCCESSION.**

Princess Kaiulani Proclaimed Successor to the Hawaiian Throne.

**A Dignified Meeting--The Nobles Present.**

**The Queen's Speech and Reply of the Nobles of the Kingdom.**

Pursuant to notice promulgated and published, the House of Nobles met Her Majesty the Queen this morning for the purpose of proclaiming the successor to the Hawaiian Throne. The meeting took place in the throne room of the Palace at eleven o'clock. The following Nobles were present: His Ex. J. S. Walker, President of the Legislature; R. D. Walbridge, H. P. Baldwin, W. H. Cornwell, W. Y. Horner, C. J. McCarthy, D. W. Pus, C. O. Berger, L. von Tempisky, H. G. Crabbe, E. C. Macfarlane, P. P. Kanoo, James Anderson, J. Kauhane and J. Phillips.

The Nobles were seated in the Throne room.

At eleven o'clock Her Majesty the Queen entered the room accompanied by the Prince Consort, Hon. J. O. Dominis; Hon. A. S. Cleghorn; H. M.'s Chamberlain, Mr. J. W. Robertson; His Ex. Hon. Samuel Parker, Minister of Foreign Affairs; His Ex. H. A. Widemann, Minister of Finance; His Ex. C. N. Spencer, Minister of Interior; His Ex. W. Austin Whiting, Attorney-General; Col. J. H. Boyd, A. D. C.; Major Jno. D. Holt, A. D. C.; Major H. F. Bertelmann, A. D. C.; Col. Hon. R. H. Baker, A. D. C.; Mrs. C. H. Clark, lady of the Court, was in personal attendance on Her Majesty the Queen.

After the Royal party had entered the Throne room prayer was offered by Hon. the Rev. J. Kaubane, after which Her Majesty the Queen read the following speech and nomination:

**Nobles of My Kingdom:**  
I have called you together to deliberate on a grave matter of State.

Article 22 of the Constitution calls upon me to appoint a successor to the Throne. The same Article calls for the approval of your Honorable Body of my appointment.

I now announce to you Our beloved Niece, Her Royal Highness Victoria Kaiulani Lunaliilo Kalaninuihahilapalapala as my Successor to the Throne of the Kingdom, and I hope that your deliberations will lead you to approve of my appointment.

Immediately afterward the royal party and the Ministers of the Crown withdrew, leaving the royal nomination to the consideration of the House of Nobles, as by the Constitution provided.

Under the spirit and letter of the law the House of Nobles immediately concurred in Her Majesty's nomination, and were received in the Blue Room of the Palace.

At this audience H. M.'s Chamberlain, Mr. J. W. Robertson, presented to Her Majesty the Queen, Hon. J. S. Walker, Noble and President of the Legislature, who then presented to Her Majesty by name the members of the House of Nobles present.

The President of the Legislature then announced to Her Majesty the concurrence of the House of Nobles in Her Majesty's nomination, in the following words:

We the assembled Nobles of the Kingdom, hereby approve the appointment by Her Majesty Liliuokalani, Queen of the Hawaiian Islands, of Her Royal Highness Princess Victoria Kaiulani Lunaliilo Kalaninuihahilapalapala as Successor to the Throne of this Kingdom.

The meeting of Her Majesty the Queen and the Nobles of the Kingdom this morning is notable for the dignity it displayed and the respect it commanded. The Royal Hawaiian Military Band, the Household Guard and royal attendants were all in full dress.

Hon. J. M. Horner, one of the Hawaiian Nobles, did not attend. The following Nobles are absent from the Kingdom: Hon. Paul Isenberg, R. E. Hind, E. A. Burchardi, Jos. Marsden and E. Muller.

THE PROCLAMATION.

Immediately after the ceremony in the Palace, the Herald went forth to publicly proclaim the Heir Apparent. Col. J. H. Boyd, chief of the royal staff, attended by Majors Holt and Bertelmann, all in full uniform, rode through the streets with a band from the Royal Guards in front. Col. Boyd read in a loud voice, in both Hawaiian and English, at the Government building, Hall's corner, the first notice and the first notice, the proclamation of the

succession of Princess Kaiulani. It being a little after twelve o'clock many people were in the streets, whose curious attention was attracted by the Herald's.

While the proclamation was thus being made, a royal salute was fired by the Hawaiian battery and the United States warships Mohican and Iroquois, in honor of the Heir Apparent.

Hon. A. S. Cleghorn, father of Princess Kaiulani, entertained a number of friends and the Herald at luncheon at the British Club. The health of his royal and popular daughter and his own health was cordially drunk.
