FERN MUST FIGHT

Two Lawyers Figure In Alleged Graft Of Iwilei Expose

Two prominent attorneys of this city have been mentioned in connection with the story of the "Twelve-Dollar-Club" in the Bulletin of yesterday. That Grand Jury investigations will follow as the aftermath of the investigations that United States District Attorney Breckons has been carrying on for several months past in the Isol slave traffic business, is now almost certain.

It is stated that, to secure immunity from arrest during the stay of the Atlantic Fleet and previous to this time as well, a large sum of money, up to \$1000 or more, was collected among the inmates of Iwilei, and was offered to a number of well known lawyers if they would "use their influence" with the police to have any and all prosecution stopped. The money was paid the lawyers.

The Department of Justice, of which Breckons is the local head, feels that matters of prostitution are local in nature and should be left to the Territorial authorities, except where the business results in peonage, importation of women for the purpose, harboring new arrivals for immoral purposes, or sales of women. When anything of

this sort crops up, the Department of Justice takes a hand.

Consequently, it is not certain whether the investigation in the matter of the police protection will be taken up by the Federal or Territorial Grand Jury. The fact remains that the names of two of the well known attorneys of the city have been mentioned, and that the minutest kind of an investigation is bound to follow.

Isol is having trouble securing an attorney to represent him in the cases, which were set for trial by Judge Dole this morning for January 11th. In some of the preliminary hearings Charles Chillingworth represented Isol and Chase, but he has withdrawn from the cases. Frank Thompson may be secured to defend the two as Isol consulted with him this morning.

PINE COMPANY GETS LAND.

Two hundred acres of land have been leased to the Wahiawa Consolidated Pineapple Company by the Wahiawa Agricultural Company for term of ten years. The annual rental of the land, which is situated at Wahiawa, is \$2000.

Fern Made Several Changes

Mayor Fern this afternoon filed a list of his appointments with the County Clerk and Auditor, as provided by law. The official list differs in some particulars from the one Fern gave out this morning, and some of these differences are quite significant.

Assistant Fire Chief Deering is retained.

N. P. Jacobsen is retained as collector of the Garbage Department.

E. B. Friel is appointed a road luna, vice Chas. Clark, who was named on the original list.

John Marshall is appointed dynamoman at the electric light station, vice Chas. F. Sackwitz, who was first named.

Supervisors To Fight Appointments By Fern

QUESTION OF HOW FAR HIS POWER TO APPOINT GOES WILL BE BROUGHT BEFORE THE COURTS BY REPUBLICAN MAJORITY, UNLESS THE MAYOR CHANGES HIS TACTICS

"I think that Fern has opened his mouth too wide, and, like many people who open their mouths too wide, he may find it difficult to close it again."

The above is the opinion which A. F. Judd of the Republican County Committee expressed in regard to the Fern appointments, and it expresses the general sentiment as heard on the street today. It is the general opinion that Fern by his sweeping list of appointments has laid himself open to a strenuous attack on the part of the great Republican majority on the Board of Supervisors, which may result in his losing the majority of his Democratic appointments, whereas he might, by the exercise of some discretion and by consultation with the members of the Board, have effected a compromise which would have been satisfactory to all parties, and which would have prevented legal complications.

That the question of how far the

appointing power of the Mayor goes will eventually have to be decided by the courts, now seems absolutely certain, though the fact that such a step may have to be taken is being deplored by the Republican leaders, who state that they would rather have the Republican majority work in harmony with the Mayor for the best interests of the public.

However, after the turn which the matter has now taken, it is certain that the Republican majority will assert itself, and that, unless Fern comes to some understanding with them, a fight will be made. The Republican Supervisors have been caucusing considerably lately, and while they have agreed to keep the course which they intend to pursue secret at present, it is well understood that they will fight if Fern tries to carry through his list of appointments. Their opposition will be based mainly on two legal points, both of which

BURTON WINS OHIO SENATORSHIP



COLUMBUS, Ohio, Dec. 31.—The election of Congressman Burton as United States Senator from Ohio is assured.

This was brought about today by the withdrawal of Senator Foraker, Charles F. Taft, ex-Governor Harris, and Congressman Keifer. This leaves a clear field to Burton.

Judge Dole Officially Sanctions An "Affinity"

Affinities, so-called, have come to Honolulu, and have been officially recognized as such. In the case of Joe Kalau and Emmeline Peter, who were arrested on a charge of violating the Edmunds Act, which came up to be set for trial this morning, Judge Dole made the above statement when he put the delinquents on probation for good-conduct.

When the case was called by Clerk Deas in court this morning, Attorney W. C. Aehl made a stirring appeal for the dismissal of the charge against the two, and asked that action against them be discontinued.

He stated that they had been married, and were fully resolved to do what was right in the future.

Assistant U. S. District Attorney Rawlins then placed some interesting facts before His Honor, showing how, even after the couple had been called before him and warned, they continued in the offense for which they stood charged. He therefore made a motion to set the case for trial. He informed the Court that Kalau had kept his paramour in the same house with his wife, until the latter started divorce proceedings.

Then it was that Judge Dole announced his belief in and gave his official sanction to "affinities." There was considerable stir in the courtroom when the announcement was made, and Deputy U. S. Attorney Rawlins muttered in a stage whisper that the long eye of the prosecution would watch the couple closely for considerable time to come.

Italian Sufferers Get \$2800

The sum of twenty-eight hundred dollars, collected in subscriptions up till 11 o'clock this forenoon, has been cabled to the relief of the sufferers from the earthquake and tidal wave in Southern Italy by Italian Consul Schaefer.

The call for financial assistance which was issued yesterday, met with prompt response. Of the sum mentioned above \$1500 was contributed by the firms of Alexander & Baldwin, Castle & Cooke and Hackfeld & Co., which contributed \$500 each. Among the other contributors ladies were especially prominent, the call of the sufferers appealing especially strongly to the gentler sex. Since the amount was sent away by the Consul, considerable money has reached him, which will be sent away later. On the whole it seems as if Honolulu's answer to the call of distress will be a very substantial one.

RECOMMENDS LIGHT FOR PAWELA POINT

Lighthouse Inspector Is Back From Trip To Maui

If the recommendation of Lieut. Comdr. Moses, lighthouse inspector for this district, is approved, there will soon be a lighthouse at Pawela, on the north coast of Maui between Puriawa and Maleko. This light, in conjunction with the new one just lighted at Nakalele, will furnish a complete safeguard to Kahului Bay and will do away with the menace of Spartan reef, where the American ship Spartan was wrecked in 1905.

FLEET SUPPLIES GO TO MESSINA

NEW YORK, N. Y., Dec. 31.—Half a million dollars' worth of supplies that were assembled here for the Battleship Fleet will be sent immediately to the sufferers at Messina.

25,000 NEEDED FOR THE RESCUE

ROME, Italy, Dec. 31.—The record of deaths from the great Sicily disaster is still incomplete, but added information only increases the horror of it.

The dead number 12,000 at Bagnara and 10,000 at Palmi. It is believed that a full regiment of soldiers was drowned at Palmi. The bodies of 300 soldiers have already been recovered.

Fully 25,000 soldiers will be required to police the devastated districts and extricate the dead and wounded from the ruins.

Starvation and pestilence are feared by the King and Queen. At Reggio the survivors state that the heavens were illuminated before the shocks of earthquake were experienced. This indicates volcanic action and lava flows.

RECORD FLYING
 LEMANS, France, Dec. 31.—Wilbur Wright made a flight with his airship today of two hours and nine minutes.

At 1 p. m. today the fund for the Italian sufferers overreached \$3,500.00, and at 11 a. m., \$2,800.00 had been cabled to Rome via San Francisco.
