TWO GOOD BASKET BALL GAMES

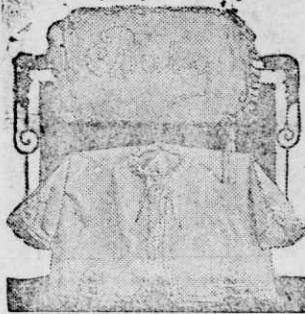
