E. CHICAGO COUPLE GET SAD NEWS

Mrs. W. H. Jeppeson is Advised of Death of Earl Jones in France.

Mr. and Mrs. W. H. Jeppeson of North Muncie, near East Chicago, are in receipt of a communication received yesterday from Mrs. Jeppeson's brother, a resident of Mercer County, Illinois, and advising them of the passing of their son, Earl Jones, who with the 9th company of machine gunners in France was looking forward to his home trip very soon, but contracted the influenza with terrible pneumonia complications and resulting fatality. The young man was in the 25th year and was on the front line when news was declared.

He wrote a descriptive account of the day when the glad tidings reached them and in a letter to his aunt in this city said he would come day by day as he intended visiting her as soon as his company would arrive. His death occurred one day later than an uncle of his living in South Dakota, from whom the Jeppesons have just returned, and the cause of death in the latter was the same which claimed that of the soldier. His last letter coming here told of the ravages of the disease among the soldiers and how many succumbed, but up to that time he was well and expectant of the voyage home.
