

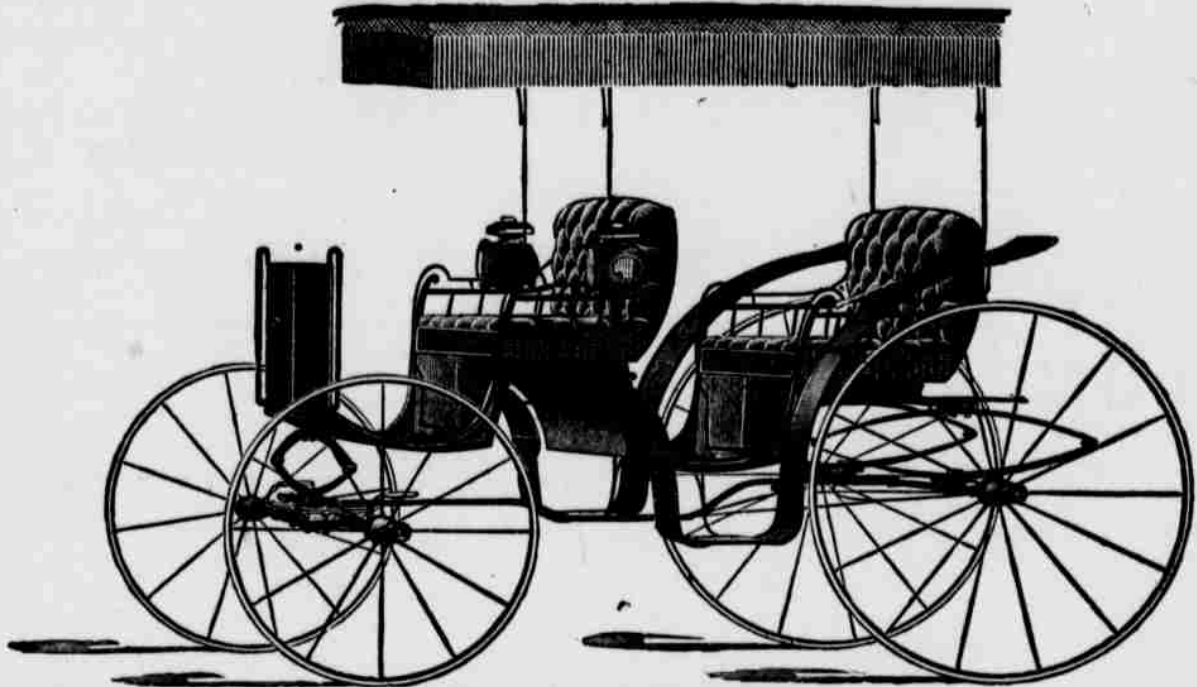

Deaths.

GLORE—Mrs. Sallie Gore, wife of Mr. John T. Gore, died Sunday afternoon at 3:45 after an illness of only a few days. The deceased was a daughter of the late Edmund V. Stephens and leaves an infant only a few days old to the care of her grown daughter. The misfortune to the family is peculiarly sad from the fact that her husband was so unfortunate several years ago as to lose both hands by the explosion of a blast, and she had since that time looked after and cared for him as tenderly as if he were an infant, and he will miss her more and more every day.

The funeral took place Monday afternoon at 4 o'clock and the remains were deposited in the family lot in the cemetery.

SLUSHER—Mrs. Frank Slusher died Tuesday at the home of her husband in the Flat Creek neighborhood, of malarial fever. Her funeral took place Wednesday.

WARREN—Mr. Lee C. Warren died at his home in New Berlin, Illinois, on Saturday, and the remains were brought here Tuesday for interment. The deceased was a brother of the late Ches. Warren, of this county, and was for many years a resident of the Forks of Elkhorn.

WELCH—Mr. James W. Welch died at 2 o'clock Wednesday morning at his home on Main street, after a brief illness. Sunday a week ago he was taken with cholera morbus, but on Wednesday of last week was able to be out again. Thursday night he was again taken ill and on Friday became unconscious, in which state he remained until his death, the disease being pronounced paralysis of the brain by his physician. The deceased was about 55 years of age and was born in Ireland but raised in this city, where he had numerous

friends and relatives. He leaves a widow, but no children, to mourn his loss. His funeral took place Thursday afternoon from the Church of the Good Shepherd.

For many years Mr. Welch was a member of the Frankfort Cornet Band, and that organization attended the funeral in a body and performed the funeral march at the head of the procession as it moved through the streets.

HOLMES—Mr. William Holmes, of this city, died at the Soldier's Home at Dayton, Ohio, on Thursday, aged 59 years. He was a tailor by trade and had been a resident of this city for some fifteen years. During the war he was a soldier in the Third Kentucky Infantry. His health failing he went to the Soldier's Home about eight months ago where he spent the remainder of his life. He leaves a widow and five children, all grown. The remains were taken to his old home at Danville for interment.
