

RESOLUTION

BE IT RESOLVED by the Board of Council of the City of Paris, Kentucky, in regular meeting assembled, that, because of the impossibility of keeping the streets hereinafter named in repair, and for the purpose of protecting the health and providing for the convenience of the citizens of the City of Paris, the improvement of the following designated streets and portions of streets, by paving the same with vitrified brick, is a necessity, to-wit:

1. MAIN STREET from Tenth Street to Fourteenth Street.
2. PLEASANT STREET from the North line of Second Street to the South line of Twelfth Street.
3. HIGH STREET from the property line between City Building and Episcopal Church to the South line of Sixth Street.
4. SECOND STREET from Main Street to Pleasant Street.
5. FOURTH STREET from High Street to Pleasant Street.
6. FIFTH STREET from High Street to Pleasant Street.
7. SIXTH STREET from High Street to Pleasant Street.
8. SEVENTH STREET from High Street to Pleasant Street.
9. EIGHTH STREET from High Street to Pleasant Street.
10. NINTH STREET from High Street to Pleasant Street.
11. TENTH STREET from High Street to the property line of the Louisville & Nashville Railroad Depot.
12. WINCHESTER STREET from its intersection with Tenth Street to the Louisville & Nashville Railroad Crossing.
13. ELEVENTH STREET from High Street to Pleasant Street.
14. TWELFTH STREET from High Street to Pleasant Street.

IT IS FURTHER RESOLVED that said streets be constructed upon a suitable and adequate concrete base and with suitable and appropriate concrete curbs and gutterings.

BE IT FURTHER RESOLVED that all of said improvements be made at the exclusive cost of the owners of real estate abutting on said improvements, to be apportioned among and assessed upon the lots or parcels of real estate abutting thereon, except the City shall pay the cost of the improvement of intersections with other public ways, including one-half of the width of the street or alley, being improved, opposite other streets or alleys which run into, but do not cross the street or alley so being improved, and of that portion of any street abutting upon property belonging to the City, and shall pay the cost of all improvements where the abutting owner is a public school, cemetery, County, State or United States.

AS TO MAILING PACKAGES TO SOLDIERS IN FRANCE.

People in this city and county who write to the soldier boys still in France after their units or organizations have sailed for the United States, should mark their letters or packages, "Please Forward. Addressee still in France," according to Postmaster J. Walter Payne. Officers and privates are frequently left behind to care for property, or adjust accounts, and these are deprived of their mail after notice is given postal authorities that the organization is returning.

The special notation on letters and packages will be necessary only until the card indexes of the War Department are received, showing what officers and what privates have been abroad in the service, and in what capacity.

GOVERNOR SETS ASIDE WEEK FOR JEWISH RELIEF FUND

Governor A. O. Stanley has issued a proclamation setting aside the week beginning April 7, as Jewish War Relief Week and calling upon the people of the State to raise the \$250,000 asked of them for the relief of the six million Jews in Poland, Lithuania, Galicia, Palestine, Turkey and Siberia who are dying of starvation, while homeless, exposed to ravages of the plague and the persecution of infuriated mobs in which the police militia join. The drive is non-sectarian, and sponsored by President Wilson, Vice-President Marshall, and governors and public officials throughout the nation.

The Governor's proclamation follows:

"To the People of Kentucky, Greetings:
"Whereas, the receding armies of the Central Powers have left in their wake indescribable scenes of suffering and privation, torture, famine and death, our duty to the oppressed and enslaved peoples of the Old World is only half finished when the invader is driven from the borders of these suffering lands. It is a pleasant and a Christian duty to minister to the wants of those whom we have made free.

"The boon of freedom itself cannot save the starving from death or the naked from the winds of winter or house the homeless.

"To-day upon the Eastern front there are untold millions of men, women and children of the Jewish race who are in direct need of the simplest necessities of life and unless they find succor here and find it without delay these wretched sufferers will sink forever under the burdens of want and oppression, torture and outrage, which no tongue can tell or pen portray.

"To the aid of these victims of brutality the Kentucky Division of the American Jewish Relief Committee have determined to carry on a campaign for the raising of funds.

"Therefore, I, A. O. Stanley, Governor of Kentucky, issue this proclamation setting aside April 7th to 11th, 1919, as Jewish War Relief days in the State of Kentucky.

"In testimony whereof I have caused these letters to be made patent, and the seal of the Commonwealth to be hereunto affixed. Done at Frankfort, the twenty-fourth day of March, in the year of Our Lord one thousand nine hundred and nineteen and in the one hundred and twenty-seventh year of the Commonwealth.
