

BOB AND THE FACTS

Minister Lincoln Addresses a Vast Crowd

IN DEFENSE OF PROTECTION

The Iniquities of Free Trade Illustrated from Practical Observations in Great Britain.

Quincy, Ill., Oct. 26.—Robert T. Lincoln, minister to England, addressed 3,000 republicans in the city this afternoon.

"Ladies and Gentlemen—I thank you heartily for this greeting here today, to me a practical stranger (a voice, 'O, we knew your daddy.' [Cheers.]

"Most of all I am glad to meet so many who knew my father. [Cheers.] I was glad to appear before you in Quincy, one of the cities visited by my father in joint debate of 1858.

"These were the days when the slaveholding democracy spoke contemptuously of northern workmen as 'the mud sills of humanity.' I do not see now a self-respecting working man can join the ranks of the democracy when he remembers the patriots that were given to him by the men who are now the hope and strength of the democratic party.

"The democratic party survives to this day as the party of destruction, destruction and death, nothing else. In 1864 it declared the war to be a failure. At the close of the war it fell to the republican party to reorganize the government and make sound laws for the development of our national resources.

"When the republican party came into power the country was under bond. There were no railroads in this great west. A man then crossed the continent in a covered wagon at the risk of his scalp. [Laughter.]

"The east there was a continuous line of railroad two hundred miles in length. The east and west were waiting for republican laws to develop and foster the enterprise of the country.

"The democrats say that the cost of living has been increased. This I utterly deny. All articles can now be bought on an average one-third cheaper than they could thirty-five years ago. I speak of quantity. It does cost more to live, but this results from what is called the American mode of life.

"They say that the cost is cheaper in England than in America. The difference, as my friends, that the American laborer can buy the coats. Across the water there are crowds to be seen who could not buy a coat if they were selling at one cent each. [Cheers.]

"There is a Mr. Springer of my own town of Springfield, who wants to punch holes, as he expresses it in the tariff. I judge that he wishes to punch it so full of holes that there will be nothing left of it but a mass of holes. I can't understand human nature. I can't understand the fact of Springer being a successful politician at Springfield, when, if he policy were to succeed, it would ruin all the great industries in that city and leave it a stagnant state capital filled with ruined workers.

"They also attack the safe and sound money system established by the republican party. It is an insult to the intelligence and integrity of American citizens to think that we wish to return to the worthless wild cat currency of old democratic rule. As I said, we have had none of that rule for thirty-two years for Cleveland was bound and fast. He was powerless, for he was a party man and the safety of the country was a republican matter. The democratic party was not in power. We did not go to the dogs thanks to that republican senate. I have no question to ask to the other question, as I have already taken up more time than was allowed me. He spoke for an hour and a half. Lincoln's speech
