WELL DONE.

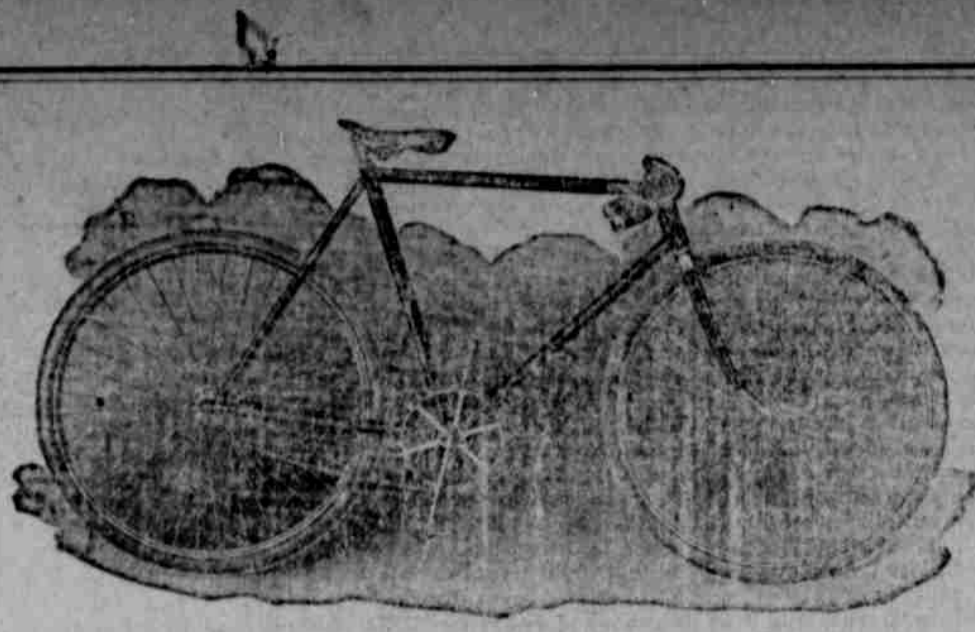
It is with great pleasure that we note the renomination of Ed. L. Parmenter for the office of county commissioner of schools for Dickinson county.
