THE CANADIAN ELECTION.

The Most Memorable Canvass in the History of the Dominion.

A VERY CLOSE VOTE WAS POLLED.

The Conservatives Seem to Have the Best of It as Far as Heard From.

The Policy of Sir John A. Macdonald Sustained in All Probability.

OTTAWA, Ont., March 5.—The most memorable canvass in the history of the Dominion has been brought to a close, the last speech made, and today the issue was decided at the polls. Party organs fired their last guns this morning and plied the party whip with vigor. At 8 p. m. the vote stands: Ontario, 20 conservatives, 24 liberals; Quebec, 8 conservatives, 11 liberals; New Brunswick, 7 conservatives; Nova Scotia, 8 conservatives, 5 liberals; British Columbia, 2 conservatives; Manitoba, 1 conservative; Northwest territory, 4 conservatives. Total 50 conservatives, 40 liberals. Conservative majority so far, 10. Hugh Macdonald (conservative), son of Sir John Macdonald, elected in Winnipeg; James Trow, a prominent liberal, elected in South Perth; Mackenzie Bowell, minister of customs, elected for North Hastings by 200 majority; Sir Adolph Caron, minister of militia, elected for Rimouski; John Ellis (liberal), editor of St. John's Globe, who was running for St. John city, is defeated by 400 majority. William Paterson, a prominent liberal, is elected in South Brant by a large majority. Hon. J. A. Chapleau, secretary of state, is elected for Terrebonne, Que., by a large majority. J. C. Patterson, conservative organizer for Ontario during the last campaign, who was running for North Essex, has been defeated. John Haggart, postmaster general, is elected for South Lanark by 500 majority. The conservatives have a large majority in the city of Halifax and will undoubtedly carry the county. The city of Ottawa has elected two conservatives. Toronto has elected three conservatives. Sir John Macdonald has been elected for Kingston by about 250 majority. Harcourt county has returned a reformer. London has elected Hyman, liberal, over John Carling. Hyman's majority is not yet known. Hamilton has returned two conservatives, giving each about 300 majority. Sir Hector Fangerin, minister of public works, has been elected for Richelieu. Hon. J. A. Quimet, ex-speaker of the house of commons is elected. Hon. David Mills, minister of interior in the Mackenzie government, is elected for Bothwell, by 2 majority. George Landerkin, leading liberal, is elected for South Creg, P. B. Casgrain, leading liberal, is defeated in Lislaw province of Quebec. J. B. Edgar, prominent liberal, is elected by over 500 majority for Western Ontario. Hon. Alexander Mackenzie, ex-premier is elected in East York. Hon. Peter Mitchell one of the leaders of the opposition, defeated in Northumberland. Hon. C. H. Tupper, minister of marine and finances, has been elected for Picton. Hon. Sir John Thompson, minister of justice, has been elected for Antigonish. Sir Donald Smith (cons) has been elected for Montreal centre. Dalton MacCarty, leading conservative is elected in North Simcoe. Sir Richard Cartwright, a prominent liberal, is elected in South Oxford by over 300 majority. William Mulock, liberal leader, is elected in North York by a large majority. C. C. Colby, president of the privy council, who was running for Stanstead, Que., is beaten. At 10:30 p. m. the vote for entire Dominion by provinces stands as follows:

Conservatives Victorious.

WINDSOR, March 5.—The hottest political battle ever fought in the north-west ended at 5 o'clock tonight. For Winnipeg, Hugh J. Macdonald, son of the premier, is elected by 500 majority. This was a big surprise to the liberals, who thought Campbell was sure of election. In Selkirk, a better fight was fought. Attorney-General Martiu was the liberal candidate, and Daly the Tory, Daly is elected as far as heard from. Watson, liberal, for Marquette, leads with Boyd, conservative, close up. Ross, conservative, elected in Lisgar. In East Assinabone, Hon. Mr. Dewdney, minister of the interior, is elected by four hundred. Davis and Meed, both conservative candidates

in West Assinabone, Davis is elected by 100. McDowell, conservative, elected from Saskatchewan as far as heard. Polling places in this constituency and Alberta cannot be reached for several days owing to the large territory. Manitoba delegation stands: conservatives 8, liberals 1.

Toronto Excited.

TORONTO, March 5.—The interest taken in the result of elections is probably unprecedented. People began to crowd upon the streets about 6 o'clock, and by 8 o'clock all newspaper offices were surrounded by great crowds. The Globe, Empire, Telegram and News published cartoons and stereoptic views on canvass in front of their respective offices. The first news that came in was from Halifax and New Brunswick, showing conservative victories. These were posted almost before the crowd had gathered and attracted less attention in consequence. Returns began to come in about half past 6 o'clock. The easy defeats of Mowat in West Toronto and Wheeler in East Toronto had been expected, but Kerr's run in Central Toronto was much less than had been confidently expected. Returns from London, Kingston and Hamilton were in by 6 o'clock. Sir John's majority was loudly cheered and Carling's defeat was bitterly both cheered and groaned. Returns from the country constituencies showing large liberal gains created a good deal of enthusiasm around the Globe office, but were much groaned at the Empire and Telegram offices. As evening wore on, the crowd became greater and the excitement more and more intense as the contest gave evidence of being very close.

Latest from Toronto.

TORONTO, March 5.—At midnight the vote stands as follows: 111 conservatives, 94 liberals. Majority for conservatives, 17. There are 215 constituencies in the Dominion which return 215 members to the house of commons. Of these, 205 have been heard from. The general conviction is that the government has secured a fair working majority. There are 13 cabinet ministers, ten of whom have been elected and three defeated.

Conservatives Elected.

VICTORIA, B. C. March 5.—The returns so far give Prior and Earn, conservative candidates, a big majority in all the divisions, and it is now certain that Templeman and Merchant, liberals, will lose. There was great excitement in the city during the day and tonight the streets are thronged with anxious people who are eagerly scanning the reports the moment they are reported.

Congressmen Finishing Up.

WASHINGTON, March 5.—The members of the fifty-first congress, who are still in Washington, are putting in an exceedingly quiet day. The greater number are worn out by the hard work of the past few days. A large number have left, but the majority still remain to close the department and other important work. Comstock is the only northwestern member that has yet departed. Congressmen Hall, Lind and Dunsell will leave Saturday. Dakota congressmen will spend some little time in the east. Senator Pierce has decided to remain here ten days. All the members from the northwest will have closed up their work at the end of the week, except the new members, who will remain for several reasons. Castle and Hall, members from Minnesota, remain to take part in the proposed national conference of the democratic leaders.

Approximate Amount of Appropriations.

WASHINGTON, March 5.—The following is an approximate statement of the appropriations made at both sessions of the fifty-first congress, prepared by the clerk of the senate committee on appropriations: Amount of regular bills, including deficiencies and miscellaneous appropriations; for the first session, \$361,700,000; amount of regular bills, including deficiencies and miscellaneous appropriations for the second session, \$405,000,000; permanent appropriations for the first session about \$191,000,000, and permanent appropriations for 1892, estimated at \$122,000,000. This makes a grand total of \$957,700,000. Senator Allison expects to have a detailed expeditious statement of these appropriations completed in a few days.

Funeral of the Late Senator Hearst.

WASHINGTON, March 5.—The funeral services over the remains of Senator Hearst, who died last Saturday night, were held at his late residence on New Hampshire avenue at noon today and were of a brief and simple character. The casket will be removed from the residence Saturday evening and will leave here on a special train over the Pennsylvania road at 7:30 for San Francisco, accompanied by Mrs. Hearst, her son, and a congressional committee.

She Must Have Her Office.

GUTHRIE, O. T., March 5.—In the contest case between the old county officials (republicans and newly-elected officials) and farmers alliance, Judge Green decided the old officials should turn over their offices, books and papers, to the new. Miss Cora Dietz, elected by the farmers alliance to be register of deeds called with her friends upon the county commissioners and demanded her office, together with the records, etc. The commissioners on a technicality refused to order the present register to comply with her demands. Miss Dietz's friends became indignant and one of them called for a rope. All her friends agreed there might be a hanging if she were kept out of office. The commissioners promised to do what was right and the excitement subsided. There will be trouble if Miss Dietz is not permitted to take her office.

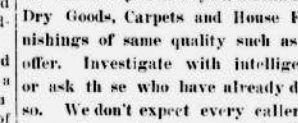

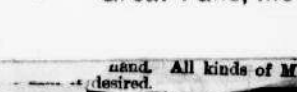
