CRIMINAL JURY IS DISCHARGED TODAY

Total of 19 Cases Brought to Trial--There Was But One Acquittal.

The criminal jury in Justice Brewer's department of the district court was permanently excused from duty today. No more cases than that of Robert Troppman, who is on trial today on a charge of robbery, were set, so the judge, after the jury had been selected in the Troppman case, permanently excused the balance of the panel.

The jury which has just been discharged was selected and the trial of cases commenced on Oct. 29. Including the case of Troppman on trial today and that of William O'Malley, tried in Boneman and prosecuted by the county attorney's office of this city, there were a total of 19 cases brought to trial. There was one disagreement, that of Homer Cole, charged with robbery and two prior convictions, and one acquittal, that of John Turpa, charged with robbery.

There were three murder cases brought to trial, not including the O'Malley case, and they were disposed of as follows:

Isaac Salomonson, tried on a charge of murder and found guilty of manslaughter, sentenced to not less than four years nor more than 16 years in the state prison.

Hassan Mehmet, tried on a charge of first degree murder and found guilty of second degree murder; sentence not less than two years.

John F. Sullivan, tried on a charge of first degree murder and found guilty of manslaughter and sentenced by the jury to not less than one year nor more than two years.

The cases heard were:

Oct. 29--Leonard Isaacson, charged with first degree assault and found guilty of third degree assault; sentenced to three months in prison.

Oct. 31--Henry Beck, robbery, found

BOYS FOUND GUILTY OF STEALING SHOES

Three Sent to Industrial School for 30 Days--One Girl Before Court.

In the juvenile court today before Judge Lower three boys ranging in age from 10 to 12 years were charged with burglary in having entered a house and carried off a pair of shoes. The case against them was established and they were committed to the industrial school for 30 days each.

Four widows representing 14 children under the age of 18 years applied for aid under the financial aid act. One woman had seven children and she was allowed \$26, which is the limit each month under the law. There was another woman with four children and she was given \$25 a month; a third had two children and she was given \$20 a month, while the fourth had one child and she was allowed \$20 a month, making a total of \$120.

A girl 15 years of age was before the court on a charge of incorrigibility. It was stated that she was out about the streets at late and unusual hours and the parents informed the judge that they had done everything possible to get her to change her mode of living, but without success. The girl said that she had a longing for pleasure shows and he would take her rather than let her go alone. "On more than one occasion," said the father, "my wife and I would go to a picture show with her and she would go upstairs and we would go downstairs. After the show we would not see her until midnight and sometimes later."

Judge Dwyer gave the girl a lecture on her course of conduct and warned her if she persisted in disobeying her parents and staying out at night she would surely find herself in the county jail or some other prison. He adjudged her guilty as charged and

opening peace negotiations with the Russian Bolsheviks may possibly have some effect on the administration's disinclination toward a declaration of war on the dual monarchy.

Administration senators gathered for the coming session of congress have fought on a conference with the executive branch of the government that there is no disposition to ask congress to make another war declaration at this time. They found the hope of breaking up the central power alliance had not been entirely abandoned.

President Works on Address.

President Wilson continued to work on his address to congress today, and the fact that he had before him a great quantity of material bearing on relations with Austria, caused some speculation as to whether he would touch on the subject. Official intimations of what the president would say still were withheld. The fact that he is holding the address open to the last minute, probably so late that adding points to it will be difficult, and that he starts to speak, puts accurate predictions out of the question. One official today said the problem of whether the government should declare war on Austria was not so easy of solution as it looked to the average citizen.

BARGAIN IN FUR OFFERED IN COURT

When Man Offers Beaver for \$20 Detective Gets Suspicious.

A bargain in coats was offered this morning in police court by R. J. Shubert, who possesses a beaver skin overcoat said to be worth \$300. Shubert offered the coat for sale at \$20 and Detective Sheehan became suspicious and placed him under arrest. Shubert claimed to have received the fur from his sister in Chicago as a Christmas present. A telegram verified the statement.

Several persons who heard of the offer by Shubert crowded about him after court and offered to buy. But Shubert changed his mind and refused an offer of \$50 for the coat. He intends to keep it, learning for the first time its real value.
