WITNESS OF THE WATER CURE

Former Volunteer Officer Testifies to Practice of the Method on Filipinos.

INVOLVES MEMBERS OF HIS REGIMENT

Says Dozen Natives Were Captured and Tortured to Secure Information of the Murder of Private O'Herne.

WASHINGTON, May 4.—L. F. Hallock of Boston, Mass., formerly a sergeant and before a private in Company I, Twenty-sixth volunteer infantry, testified before the senate committee on the Philippines concerning the practice of the water cure in the Philippine archipelago.

Mr. Hallock told of the infliction of the water cure upon a dozen natives at the town of Leon, province of Zamboanga, in 1900, the cure was administered by Private O'Herne of Company I, who had been not only roasted, but otherwise tortured before death ensued.

Captain Glenn, in charge of a scouting party, had first secured a confession and participation in this crime by one native who had implicated twelve others.

What was the effect of the punishment? "The stomach would swell up and in some cases I witnessed blood come from the mouth."

Asked what became of the prisoners to whom the cure was administered he replied that they were placed in a guard-house twenty by twenty-five feet in size, in which there was one window and in which there were at times eighteen men confined.

Mr. Hallock also stated that he had been present when a village of 3,000 had been burned and that the occupants of the houses had had no time to carry out their property.

He had known of three or four other cases of such destruction of property, but had not been an eye witness.
