METHODIST DOCTRINE and DISCIPLINE

Can All Men Be Saved?

Rev. D. W. C. McIntire preached the eleventh and last of the thirteen sermons on Methodist Doctrine and Discipline last Sunday evening from

the following text:
"God our Saviour; who will have all men to be saved, and to come unto the knowledge of the truth."—1 Tim.

12:3-4.

Is it possible for all men to be saved? To escape the just penalty of their transgressions? This is not a question of idle curiosity seeking to pry into the secrets of the most high, but one so closely connected with our peace of mind, that a satisfactory answer is reasonably demanded. The Christian Church of to-day has but little controversy on this subject, but in the past, our question has formed a battle ground for theological giants, and has even tent the body of Christ. (the church) in twain.

The teaching of Methodism has always been plain and unequivocal on

The teaching of Methodism has always been plain and unequivocal on this subject. She has boldly taught without any mental reservation, from her pulpits and in her theological schools, and standard works that all men, everywhere, without respect of person, can be saved, and while we have been free, to teach that many are lost, yet we locate the responsibility for that loss in the will, of the individual and not in any barrier, or circumstance erected by the creator.

The doctrine of salvation, conditioned upon the exercise of faith and obedience to Christ, was taught and not disputed until the fourth century when Augustine, a man with comprehensive learning and acute intellect, taught that God from eternity made a free and unconditional decree to save a tew from the great mass of corrupt humanity and to these thus elected to salvation he gives the requisite means that

ity and to these thus elected to salva-tion he gives the requisite means that they may believe and practice righteous-ness, but that the great mass of the race, not elected, are left without the means of salvation. This doctrine was embraced and taught by John Calvin, of 16th Century, who having embraced the doctrines of the reformation, wrote forcibly against the errors of Roman-ism, and borrowed an l vigorously de-fended the doctrine of Augustine con-cerning election and reprobation.

ism, and norrowed an Vigorousy defended the doctrine of Augustine concerning election and reprobation.

Methodism, however, holds to the doctrine of Arminius who is described as "one of the most learned men of a learned age." Finding his teachings more in harmony with the scripture and the revealed character of God, our Church teaches that God has ordained to save through and because of Christ, all who will believe and continue in faith and obedience to Christ, but to condemn the unregenerated and unbelieving as aliens from Christ. See John 3:36. This doctrine is now generally taught and received throughout the Protestant Church.


1. "Some men seem to have a constitutional difficulty in believing the scriptural plan of salvation." It is true, faith is necessary to salvation, but there is nothing in the scriptures, that is not supported by evidenceand as evidence considered and weighed, is the natural method of arriving at conviction, so if the evidences of Christianity are studied and carefully weighed they will produce conviction of the truth to all but the willfully stubborn. The honest enquirer after truth will not remain long a sceptic, after he begins to investigate the grounds of the claims of Christianity.

2. "Some men never seem to have a religious desire or any drawing toward religion." This is because they have totally neglected to cultivate the religious element. They have cultivated every other, but have overlooked this.
