able Social Events Being Held Daily at Santa Fe.
 Wednesday morning the New Mexico Educational association in the absence of President Jordan was called to order by C. L. Herrick, president of the university at Albuquerque. The association was led in prayer by Rev. A. A. Hyde, of the M. E. church. Professor Herrick was elected president of the association, and Miss McIntyre, of Gallup, secretary pro tem. After which an adjournment was taken until 2 p. m. The afternoon meeting Wednesday was called to order by the president at 2 p. m. The first paper was "The Beginnings of Moral Training." In the absence of the author, Professor Hadley was chosen to read the paper. Professor Hadley, President Hewett, Professor Hodgkin and Professor McClain discussed the subject and brought out many good points. The next paper, "The Kindergarten," was read by President C. M. Light. The paper showed careful preparation and was listened to with interest. The topic was ably discussed by Miss Hill of Las Vegas. Mrs. Weltner then read a paper on "The School and the Home." Professor A. B. Stroup followed with some good ideas on the subject. The attendance during the afternoon session was about 100, a much better attendance than usual for a day session. The exercises and reception Wednesday evening constituted a noteworthy event. In the dining room of the Palace hotel, which was prettily decorated with evergreens, a large audience assembled. Hon. George H. Wallace secretary of the territory, made an eloquent address of welcome. He dwelt on the progress that had been made in educational matters in the territory despite drawbacks which seemed insurmountable, and declared that New Mexico need not be ashamed of its educational facilities, which compare favorably with those of other commonwealths. Professor C. E. Hodgkin, principal of the Normal department of the University of Albuquerque responded. He reviewed the history of the educational association, which thirteen years ago was founded in Santa Fe mainly through the efforts of Santa Fe residents at that time. He is the only original member of the association still in the territory. Professor C. L. Herrick, in the absence of President Jordan, of the association, made the annual address. Discarding a learned peroration which he had prepared he took his hearers upon a journey into the fields and woods and described very entertainingly phases of plant and animal life which are known only to close observers and students, and drew lessons therefrom for the teacher and the pupil. He referred to the work being done by the university of Albuquerque in a scientific way to demonstrate that the atmosphere of New Mexico contains but few of the noxious bacteria found in the atmosphere of low and moist levels, and the studies being made at the university laboratory of means to destroy the power of even those few noxious bacteria found in this section. The audience then went to the parlors of the Palace hotel to assist the Woman's Board of Trade in tendering a reception to the visiting teachers. The reception committee consisted of Secretary and Mrs. Prince, Mrs. E. P. Critchton, Mrs. Rivenburg and Solicitor General E. L. Bartlett. The teachers and others were in turn introduced to the committee, and an hour or two were spent very enjoyable in a social manner. About 200 people attended the reception. One of the surprises of the affair was the delightful music rendered by an orchestra of local musicians recently organized. The association was called to order Thursday morning by the president. In the absence of the secretary, Miss Porter was chosen pro tem. The following committees were appointed: Resolutions, Profs. Hadley and Marsh and Miss Maggie Bucher; place of meeting, President Light, Superintendent Chapman and Professor Hodgkin; nominating committee, Professor Richards, Professor Hickey and Professor Cockrel; auditing committee, Professor J. A. Wood, Professor Givens and Professor Drake. "The Physical Child" was the subject of the first paper read by Professor W. B. Givens.
