NEW YORK, June 1.—Wilson D. Bissell, President Cleveland's former law partner, called upon Miss Folsom at noon today.

This evening he said President Cleveland and his bride would soon take a trip to Europe. The date of their departure, however, he could not say. It was his intention, he said, to accompany them abroad. The trip will probably be made, he added, just after congress adjourns.

BOTHERED BY CRANKS.

Miss Folsom, since her arrival in this city, has received heavy mail and not a few letters from "cranks." This morning's mail brought her a letter from a man in Cleveland, Ohio, signing himself "J. J. Martin, A Friend of the Laboring Class." He wanted to know if she would teach her husband to study a plan for the amelioration of the sufferings of the laboring classes. "Will you," he wrote, "advise your husband how to deal with this question, and will you, when you are a mother, teach your children to have the interests of the laboring classes at heart." "We know," the letter concludes, "that you are large of heart and will respond to these entreaties."

Miss Folsom and her mother devoted the spare time of the afternoon to making preparations for the trip to Washington.

Dorsey Falling Rapidly.

WASHINGTON, May 31.—Ex-Senator Dorsey, before leaving for Europe, delivered himself of a long interview on the political situation. He says republicans can have another quarter of a century in control of the government if they will rid themselves of the silk stockings, white hats and George Wm. Curtis, and adds:

"Blaine's chances of nomination are better than they ever were, but I believe that General Logan and John Sherman will jointly have a majority of the votes of the convention. There may be a re-nomination of the Cincinnati convention of 1876, when Blaine came near a nomination, but failed. One thing is certain, Blaine is too experienced a politician to permit a tierfield to appear in the national convention from Maine, although Tim Reed is quite equal to the role. I believe that there will be fewer names before the next convention than before any that has been held."

John Kelly Dead.

NEW YORK, June 1.—Mr. John Kelly, who has been ill for several months, has, during the last few weeks, seemed to feel comparatively well, but on Sunday last he was taken with an attack of fainting and became weaker and afterward on Monday he was worse, but this morning an important change was apparent. At noon, however, he began to sink and the approach of his end was realized. Mr. Kelly's death was painless, although he was conscious to the last moment.

Mrs. Kelly and her two children were present when the patient passed away. Mrs. Kelly was prostrated by the blow and is too ill to see anybody.

Against the Evolution Theory.

AUGUSTA, Ga., June 1.—Today's proceedings of the general assembly of the Presbyterian Church South was devoted to the discussion of the question of evolution. Dr. Woodrow closed the debate. He did not speak in support of or even advance the theories of evolution, but spoke against the propriety of the convention taking action now, and against the assembly adopting the report of the majority alleging the creation to have been immediate. The majority report was adopted by an overwhelming vote—137 to 13. It is as follows:

To the several overtures on the subject of the evolution of man sent up by the Presbyteries, the general assembly returns answer as follows:

The church remains at this time sincerely convinced that the scriptures, as truly and authoritatively expounded in our "Confession of Faith" and catechism, teach that Adam and Eve were created body and soul by immediate acts of Almighty power, thereby preserving perfect race unity; that Adam's body was directly fashioned by Almighty God without any natural animal parentage of any kind, out of matter previously created of nothing, and that any doctrine at variance therewith is dangerous error, inasmuch as by methods of interpreting scripture which it must demand, and in the consequences which by fair implication it will involve, it will lead to a denial of doctrines fundamental to the faith.

Events at the Capital.

WASHINGTON, June 1.—The cabinet session today was devoted to the consideration of the Canadian fisheries question and the action of congress in regard to the Geneva award and railroad matters.

CONGRATULATING THE PRESIDENT.

Many senators, representatives and other officials called at the White house today and congratulated the president on his approaching marriage. He was in a very happy frame of mind and endured the chaffing and pleasantries of his visitors on the subject of his wedding with the utmost good nature.

MANNING ON DECK AGAIN.

Secretary and Mrs. Manning will attend the president's marriage. This will be the first social entertainment of any kind Secretary Manning has attended since he was taken sick.

Defeat of the Salvationists.

BELOIT, Wis., June 1.—There was an exciting scene at the corner of Bridge and school streets tonight that nearly assumed the proportions of a riot. It grew out of a street meeting of the Salvation army. The Salvationists have held nightly parades on the streets and pounded bass drums until Mayor Parker has ordered them to desist, but they have failed to obey. While the meeting was in progress tonight the mayor ordered them to return to their quarters. The words were hardly out of his mouth when a portion of the crowd made a rush upon the now terrified Salvationists, and eggs and missiles were thrown promiscuously; some of Salvation soldiers being considerably hurt. A wild scene ensued for a short time, during which ugly threats were made against the soldiers, and the leaders were put in the lockup. Among the Salvation soldiers were several women and children, residents of the city, and they have some public sympathy in their behalf.

Cattlemen Must Move.

GAINESVILLE, Tex., June 1.—A notice to the cattlemen of the Chickasaw Nation was issued here today by United States Agent Robt. L. Owens, stating that June 24 had been fixed as the time in which cattlemen will be required to have their cattle removed from the Union agency. If the order is not honestly obeyed, the agent says he will proceed to collect and eject intruding cattle with regular cow outfits employed for the purpose.

WASHINGTON, June 1.—The house spent the day discussing the oleomargarine bill, and acting on proposed amendments, but all proposed were defeated and the house adjourned without coming to a vote on the bill. The majority for the bill when it comes to a vote will be about eighty votes.

The Senate.

WASHINGTON, June 1.—In the senate today the time was principally devoted to a discussion of the Northern Pacific grant for forfeiture bill, and after a long discussion of the same, and an executive session the senate adjourned.

HARMONY IN A HORN.

The Love Feast Results in Much Talk and No Work.

The Old Sores Handaged, Healing Salve Applied, and Results to be Awaited.

ALBUQUERQUE, N. M., June 1.—As this city covered itself with glory Decoration day, the local patriots came to the conclusion that the much-talked-of procession, consisting of bands, torch-lights, mounted horsemen and beer, with which the visiting delegates to the republican sacrifice held here tonight were to be welcomed, entailed quite too much exertion, so the territorial republican gusa dribbled in one by one, and were allowed to take care of themselves, until there were enough present to dignify the gathering by the name of a quorum, although the absence of a large number of delegates from the southern part of the territory made the gathering very slim. Quite a number of the faithful present looked upon and spoke of the

WASHOUT AT ISLETA AS A GOSEND accident to prevent the appearance on the scene of a certain faction of the grand old party who for the good of those present were better absent.

The long anticipated love feast convened in the sample room of the San Felipe hotel promptly at 8 o'clock. Men who had not asked each other to take a drink for years fell on each other's neck and wept. Tom Hughes, editor of the Journal, and Ira Bond, editor of the old town Delirium Tremens, buried the pen, and Colonel Breeden allowed Colonel Chaves to shake one finger, which he majestically held out to him. But, alas, this state of brotherly love was not to last. Hardly was the meeting organized by the election of Colonel J. W. Dwyer, who had succeeded in persuading each faction that he was solid with them only, chairman of the meeting, when hideous discord broke the peace of night.

Nobody was present from the southern part of the territory; Lincoln, Grant, Dons Ann, Sierra and Socorro counties

WERE ENTIRELY UNREPRESENTED, but to make up for the absence of the committeemen from that quarter there were present Prichard, Colonel Richard Prichard, Dick Prichard, ex-District Attorney Prichard and Secretary Prichard, for to that position were these gentlemen elected. Colonel Breeden, Attorney General Breeden, and Bill Breeden were also present in full force as also was Colonel J. Francisco Chaves.

W. D. Lee was present from Las Vegas, but he must have been sat upon early in the day as he kept remarkably quiet during the convention.

Colonels Breeden and Prichard were the most numerous gentlemen in the matter of talking and

when it came to voting.

The first rupture came up over a resolution moved by Tom Catron, which was promptly amended by Colonel Prichard. As amended it was to the effect that

WHEREAS, There had been two territorial republican central committees; and, whereas, these two committees loved each other in a way that broke the David record all to smithereens; that, therefore, these two committees should be one, like man and wife, and Colonel Dwyer, the plump but pleasing chairman of the meeting, should be chairman of the wedded committees, with power to call them together to fix the time and place of holding the next republican convention.

Scarcely had Colonel Prichard read this resolution when the other

RED HEADED COLONEL

jumped to his feet and proceeded to set down on his fellow colonel and the resolution. He said there was no two republican central committees; that there could not be two; that there were but one, and that there had been some boaters from it and the resolution ought to state the facts as they were.

Ex-District Attorney Prichard defended the resolution introduced by Colonel Prichard, and said that there were two republican parties and everybody knew it.

Attorney General Breeden renewed the attack upon the resolution and

and proceeded to light into all the Breedens and Prichards. He said he had come there for harmony and he intended to have it if he had to lick everybody in the room. If they were disposed to split hairs they could find plenty of them to split. He characterized the resolution as a firebrand, and said that he did not want to get into a fight, because he did not want to get licked, but if a fight was inevitable he could stand it as well as anybody.

Richard Prichard weakened under this onslaught and consented to have his resolution amended so as to read, "Divisions of the territorial republican central committee." Instead of, "Two territorial republican central committees," wherever the latter occurred in the resolution. The resolution was

VOTED ON AND CARRIED,

whereupon Col. Chaves moved to second it. The chair sat promptly down upon him by informing him that it had already carried.

Governor Stover then made a motion that Col. Dwyer be empowered to fix the time and place for holding the convention, without calling the committees together at all. Col. Chaves, who thought he was all right with Dwyer, spoke in favor of the motion, and said he thought the committee had better not meet; if they did they would be sure to wrangle. There were two wings to the party and Colonel Dwyer represented both wings,

LIKE A CHICKEN,

under which he and Colonels Breeden

and Prichard and the other chicks could peck.

This simile of Colonel Dwyer as an old hen and the other three colonels as chicks, was a striking one and brought forth applause from the other committeemen, and the motion might have carried, but just then Walter Hadley discovered that this point was already covered by the resolution which had already been adopted and that it was therefore not in order until reconsidered.

This brought Stover, Breeden and Lee to their feet at once and confusion reigned until

GOVERNOR STOVER LET OUT

the full strength of his voice, when Breeden and Lee resigned themselves to the inevitable and sat down.

A motion to reconsider the resolution was made. Breeden, Otero, Prichard & Company began to suspect that there might be milk in the coconut of Chaves' confidence in the chairman, so the motion to reconsider was at once voted down; Colonel Chaves, however, secured another vote on the question on the plea that nobody knew what they were voting about.

He explained that if the resolution stood as adopted the chairman would have to call the committees together again and give them

A CHANCE TO SQUABBLE,

and also that one committee was stronger numerically than the other and so could out-vote it, which he did not consider a fair deal.

After he got through Colonel Prichard made a few remarks, and the vote was again taken, resulting in Colonel Chaves' downing again, Chaves, Stover and Luna being all the votes in favor of a reconsideration, and Otero, Hadley, Breeden, Lee and Prichard voting the other way.

A motion was afterwards carried that in the event of the committees not being able to convene from any cause Colonel Dwyer should fix the time and place for the convention.

Breeden then stated that all the business of

THE MEETING WAS OVER

and he stated he would like to hear some speeches and he called upon Judge Axtell to speak, whereupon your reporter came away. Nothing whatever has been done at this love feast but to provide for a future meeting of both central committees. If there had been any hope of harmony at present all that has been delegated to this future meeting would have been done at this one. It has been postponed solely in the hope that before the committees are again called together, the leaders of the factions may be able to come to some agreement.
