

BEATTIE CONFESSES MURDER OF WIFE AND DIES FOR THE CRIME

In Final Statement Given at Eleventh Hour, Young Virginian Says He Wants to Be at Peace With All.

SOLEMLY SIMPLE IS HIS LEGAL EXECUTION

After Reading of Death Warrant, is Marched to Chamber and Seated in Chair; Then Warden Raises Hand.

(By Evening Herald A. P. Leonard Wire) Richmond, Va., Nov. 24.—Henry Clay Beattie, Jr., before his death in the electric chair at 7:23 a. m. today, confessed to the murder of his wife.

"I, Henry Clay Beattie, Jr., desirous of standing right before God and man, do on this the 23rd day of November, 1911, confess my guilt of the crime charged against me. Much that was published concerning the details was not true, but the awful fact, without the harassing circumstances remains. For this act I am truly sorry, and believing that I am at peace with God and man, I am at peace with all.

Throughout the forenoon the city had been rent with rumors that Beattie had confessed. These were denied at the penitentiary, where in connection with the announcement of the death it was said the condemned man had made no statement.

The confession was evidently made at the eleventh hour, when Beattie finally became convinced that all hope of escaping the electric chair had passed.

Two days ago, Rev. Dr. Fix announced that Beattie said he would not confess. This was ascribed to the fact that Beattie desired to spare his father the blow of admitting guilt after his many protestations of innocence to the aged parent.

There was a fight between Beattie and the doctor who was to perform the operation. The doctor took his place, the prison surgeon and the electricians adjusted the straps, a half dozen clamps were quickly thrown into place and snapped.

The cap, resembling a leather football helmet, was adjusted, and the man stepped back. The warden raised his hand. Instantly Beattie's body stiffened with such violence that the straps creaked as though they were castanets in the hands of death, and then that which once had been Henry Clay Beattie, Jr., relaxed.

Most of Testimony of Mrs. Patterson Concerning Her Life is So Morbid As to Be Unfit for Publication.

BEATEN, CHOKED AND MISTREATED IS PLEA

Young Woman Reveals Existence of Shame That Has Seldom if Ever Been Equalled in Records of a Court.

(By Evening Herald A. P. Leonard Wire) Denver, Colo., Nov. 24.—Much of the testimony of Mrs. Gertrude Patterson, who today resumed the witness stand in her own defense on a charge of murdering her husband, Charles A. Patterson, was unfit for publication.

"Taking up the subject of Patterson's illness—it is said he was nearly dead from tuberculosis of the lungs when he was killed—Mrs. Patterson said that she had nursed him until a physician ordered her to take a rest. She continued to visit him, however, and one day, she testified, he exclaimed: 'If you don't come back and nurse me I'm going to see that I die.'

"He patted his pillow," continued the witness, "and said 'I have the thing here that will kill you.' From the hospital where this scene is alleged to have transpired Patterson was taken to a sanitarium, where he lived in a house tent. For a time he declined to see his wife, but once, she said, she was admitted.

"He drew a razor," related Mrs. Patterson, "and said: 'I'll kill you as sure as I live.' In July, 1910, witness said she filed suit in Chicago for divorce, and went to live with her parents in Sandovail, Ill.

"My husband kept after me for money, saying that he wanted to go west for his health," narrated Mrs. Patterson. "When I told him that I had some he said: 'Get it from that fat cow.' This was a reference to the Chicago millionaire whose name has been brought into the case.

"I was while they were in Chicago that Patterson insisted that she secure more money with which he desired to purchase a piece of property. Mrs. Patterson declared she would apply for no more, whereupon she testified her husband exclaimed: 'I think I will see that you get it—by taking you to Europe and get the money.'

"It was then that Mrs. Patterson says she confessed to her husband that she had five thousand dollars given her by Strauss while they were in Europe. She gave her husband \$1,750 of it to buy the property. At this point the testimony took on a character which was succeeded by a dead, shocked silence in the court room. (Unfit for publication.)

Attorney Milligan objected to the sentence, saying he thought it excessive. Thirty days, he suggested, would have been severe enough punishment.

BEATTIE CONFESSES MURDER OF WIFE AND DIES FOR THE CRIME

In Final Statement Given at Eleventh Hour, Young Virginian Says He Wants to Be at Peace With All.

SOLEMLY SIMPLE IS HIS LEGAL EXECUTION

After Reading of Death Warrant, is Marched to Chamber and Seated in Chair; Then Warden Raises Hand.

(By Evening Herald A. P. Leonard Wire) Richmond, Va., Nov. 24.—Henry Clay Beattie, Jr., before his death in the electric chair at 7:23 a. m. today, confessed to the murder of his wife.

"I, Henry Clay Beattie, Jr., desirous of standing right before God and man, do on this the 23rd day of November, 1911, confess my guilt of the crime charged against me. Much that was published concerning the details was not true, but the awful fact, without the harassing circumstances remains. For this act I am truly sorry, and believing that I am at peace with God and man, I am at peace with all.

Throughout the forenoon the city had been rent with rumors that Beattie had confessed. These were denied at the penitentiary, where in connection with the announcement of the death it was said the condemned man had made no statement.

The confession was evidently made at the eleventh hour, when Beattie finally became convinced that all hope of escaping the electric chair had passed.
