PLANNING HIS AUTO RACE ON TRACK AT JUAREZ

El Paso Motor Club Seeks Sanction for Three-Hundred-Mile Event to Be Run in September.

(Special Dispatch to Evening Herald.)
El Paso, Tex., July 17.—The El Paso Auto club has applied to the A. A. A. for a sanction for a 300-mile auto race to be run over the track of the Jockey club in Juarez, Mex., the last week of September next. The track is one of the best on the American continent and it can be had for the purpose of holding an auto race. It is said, by the promoters of the proposed meet, if after the race it is restored to proper condition for horse racing.

It is the intention of the promoters of the auto race to bank the turns heavily so as to make them safe. The plans have been submitted to a number of men well versed in the auto racing game on circular tracks and they say record time can be made on the Juarez track if the plans are carried out.

Purses aggregating \$5,000 will be hung up to be competed for in the several races which, in addition to the proposed 300-mile race, will make up the three day program to include Transcontinental travel, and from the exposition at San Francisco and San Diego, will be at its height at the time the races will be held. Today's War Summary

Russian lines are holding well immediately north of Warsaw, where the greatest force of the Teutonic army against the Polish capital is being exerted, according to the latest statement from Petrograd. Attacks by "important forces" west of the river Orza have been repulsed with heavy losses, the Russian claim, and in sections where gains were made by the Germans, their further advance was arrested.

A withdrawal of the Russian forces between the Pissa and Orza rivers to new lines along the Narva in the face of General von Hindenburg's attacks is admitted by Petrograd. Continuation of the German advance in Courland also is conceded. Increasing importance is attached by military observers abroad to the movement in the Baltic provinces.

Field Marshal von Mackensen's army that swept through Galicia is giving signs of renewed activity in pursuance of the assumed plan of the Teutonic forces to attack simultaneously all along the sweeping 500-mile front from the Baltic to Bessarabia. Unofficial reports through Geneva declare that at the lower end of this line Austrian troops have been driven back to the other bank where their retreat is being turned into a fight.

Fighting on the Agordo-Italian front has resulted by few recent changes, according to latest reports. Numerous attacks by the Austrians on the Italian advanced position are recorded, all of which are declared to have been repulsed.

TRUSTEES OF ANTI SALOON LEAGUE ENCOURAGED

Superintendent Seder Reports That Twenty-Four Counties Have Held or Will Hold Prohibition Elections.

The prohibitionists claim to be making progress in New Mexico, as elsewhere. According to the report of the Rev. J. I. Seder, state superintendent of the Anti-Saloon league, which was read before the trustees of the league at their annual meeting in this city last Thursday morning, twenty-four out of the twenty-six counties of the state either have held or are preparing to hold elections under the present local option law, and if results continue to favor the drys there is prospect that outside of the municipalities New Mexico may become arid indeed.

Chaves, Curry, Eddy, Luna, Otero, Quay, Roosevelt, Sierra, Torrance and Union counties are almost entirely free of saloons and large portions of Colfax, Mora and San Miguel counties recently voting dry put those counties in the same class. Sandoval county is getting ready for a campaign, and south of Albuquerque there is a stretch of 250 miles in which are to be found only six places having licensed saloons. From Helen to Clovis, a distance of 240 miles, only one town still retains saloons. And so it goes over the state. The Anti-Saloon league is following the policy of applying the sponges to the mop in spots, while at the same time working for a submission law that will give the temperance people the chance to swing New Mexico into the column of eighteen states which are now committed to prohibition. The league is not discouraged by the failure of the last legislature to give the state such a submission law, nor by the failure of the Santa Fe campaign against the saloons. They say that every local option fight does good, whether they win or lose.

The treasurer's report shows that the league collected and spent \$2,500 in its work during the past year. The money is raised by the sale of magazines in the form of subscriptions and offerings in churches. Ministers of practically every denomination, including many of the Catholic clergy, are cooperating in the work of the league.

It is feared that the league may lose the services of Rev. J. I. Seder as superintendent. He offered his resignation at the trustees' meeting, giving the impaired health of Mrs. Seder, who is now in California, as the principal reason for his action. His resignation was not acted on, but was referred to a committee which is to confer with Mr. Seder, with the understanding that the latter will continue in his present duties at least until November 1.

Rev. S. H. Hoffman, of wagon Mound, is chairman of the board of trustees, and Rev. E. P. Schuler, secretary. The headquarters committee, which has power to act for the trustees during the interim between meetings of the latter body, is composed of local evangelical pastors.

BANK SUES TO RECOVER UNDER NOTE FOR \$1,300

The First National bank has started suit in the district court against W. H. Andrews and W. S. Hopewell to recover \$1,887 and interest, due on a note alleged to have been given by Andrews to Hopewell last January. The note is alleged to have been for \$1,300, and for four months. Hopewell sold it to the bank, guaranteed payment, it is alleged. Laurence F. Lee is the bank's attorney.

PUTTING CHARITY WORK ON FIRM FOUNDATION

Finance Committee Pursuing Plan to Provide Funds for Systematic Relief for at Least a Year.

The permanent finance committee of the Civic Betterment league will meet this afternoon to further plans for a fund that will insure organized charity work in this city for a year at least. A meeting was held last night and before the committee met, some \$225 subscription were in hand.

L. H. Wolf, a welfare expert who is temporarily a tag as secretary of the league, presented a statement at the meeting that made plain the efficiency of the league work. His statement showed that in the last three months the Civic Betterment league had obtained more from relatives and friends of persons who came under its notice than had been collected from all of Albuquerque, so far the league has spent \$217 of its relief fund. Six hundred and forty dollars has been given to the league by friends and relatives of "cases," all of which has been spent for the persons (to whom it was intended).
