MUNICIPAL MATTERS.

The Usual Routine Business Transacted by the City Council Last Night—Provision for Stone Gutter on Frisco Street—New Appointment.

The city council met in regular session, last evening, with Mayor Easley in the chair and Councilmen Andrews, Delgado, Dominguez, Holmes, McCabe and Sena present.

The minutes of the previous meeting were read and approved. The city clerk reported as follows: Licenses collected, \$40; warrants drawn during September, \$900.43.

Four cases regarding the reported twenty-four poles tried during the past month. The city marshal reported fines collected during the last two weeks of September, \$18, and expenses paid, \$16.

These reports were referred to the proper committees. The marshal, in the capacity of ex officio street commissioner, reported as follows regarding street work in the 4th ward: Total number of registered voters, 272; over age and out of town, 80; worked or paid in cash, 131; cash collected, \$77.70. Referred to committee on streets and bridges.

The city attorney asked and was granted interest at the rate of 12 per cent on his salary warrants from October 1.

The committee on streets and bridges was granted authority to act in the matter of building a stone gutter on San Francisco street from the Arcade corner to the narrow gauge railroad crossing.

The street commissioner was authorized to buy the necessary lumber for a bridge across the arroyo in front of the Glider's place.

An ordinance, creating the office of city driver and defining the duties and compensation thereof, was passed.

The committee on police reported that Sheriff Cunningham was willing to continue feeding the city prisoners for 50 cents per day and accept warrants amounting 10 per cent interest therefor.

The city marshal's reports for August were approved. A communication from the Diocesan association, inviting the mayor and city council to attend the exercises and participate in the parade incident to conferring the pallium upon Archbishop Chapelle, was read and the clerk instructed to notify the association that the invitation was accepted with thanks.

The mayor's appointment of Manuel Ortiz y Rodriguez as policeman, vice Antonio Sena, term expired, was confirmed. The mayor and city clerk were authorized to execute a quit claim deed in behalf of the city to the old Masonic and Odd Fellows' cemetery, north of the federal building, and deliver the same to the proper lodge officials.

The council thereupon adjourned.

The weekly prayer meeting in connection with the Presbyterian church will be held for the present at the mission house until the church building is lighted with electricity, which will be done without any undue delay.

Joseph Tedaldi and family, of Salt Lake, have arrived here to make their home. They appear to be thrifty people. Mr. Tedaldi has leased the Delgado store room, formerly occupied by Welmer, where he will open a fruit store and possibly a restaurant.

Bert Easley and a surveying party, which includes Tom Goodwin and the mountaineer, Joe Blonger, left to-day for a three weeks' trip to the Pienris and Las Truchas regions in Taos county. They go on government survey work, but for fear of encountering a bear Tom Goodwin took his rifle.

COUNTY COMMISSIONERS.

Assessment Rolls for 1895 Submitted and Approved—Total Valuation—Reduction of the Levy as Compared with 1894—Accounts Audited.

The county commissioners met at 2 o'clock yesterday afternoon. Chairman Dandrow presided, Commissioners Rogers and Lujan were present and Clerk Hill officiated at the desk.

The petition of the residents of Pojoaque for the establishment of a public road to Nambu pueblo was granted.

The tax rolls for 1895 were submitted by the assessor, examined and approved. The total valuation of property in the county is \$2,152,392.

The valuation of property within the corporate limits of the city of Santa Fe is fixed at \$981,175 for 1895. The total assessed valuation of the county is over \$100,000 less than in 1894.

The following is a list of the taxes levied for 1895: For territorial purposes, \$12,911.33; For territorial institutions, 2,798.53; For cattle indemnity fund, 4.42; For school fund, 5,207.63; General county fund, 6,471.17; Court fund, 12,911.33; Interest on bonds, 1,320.25; Interest on bonds, 193.92; Interest on bonds, 1895, 209.15; Road tax, 1,070.30; Judgment, 319.20; City of Santa Fe, 8,530.58; City of Santa Fe, school, 4,962.87; School district, No. 1, 5.10; School district, No. 2, 319.20; School district, No. 3, 556.15; School district, No. 4, 21.62; School district, No. 5, 10.21; Grand total, \$73,657.35.

The total taxes levied in the county for 1894 was \$95,661.90. The reduction of nearly \$20,000 is chiefly owing to the fact that the board decided to make no levy this year for the payment of interest on certain railroad bonds.

The following, offered by Commissioner Rogers, was unanimously adopted: Whereas, Francisco Gonzales y Baca has this day turned over the tax rolls of Santa Fe county for the year 1895, and the same having been approved by said board; be it

Resolved, That the county treasurer of said Santa Fe county be ordered to retain the amount of 4 per cent of all taxes and licenses collected by the collector of said county for the year 1895, and that no warrant shall be drawn by him upon said money except for the payment of said assessor's commission.

The county clerk was instructed to address a letter to the council of the city of Santa Fe, asking for a list of the names of all city prisoners confined in the county jail under the city's contract with the sheriff.

The following accounts were audited and approved: W. P. Cunningham, sheriff, \$281.50; Juan Antonio Valdez, jailer, \$50; Jose Amado Martinez, jailer, \$50; Cayetano A. Garcia, jailer, \$50; A. P. Cartwright, treasurer, \$75; Cosme Herrera, school superintendent, \$265.35; Francisco Anya, constable, \$4; Tomas Smith, justice, \$6.50; Patrocinio Sanzola, constable, \$46.50; Jose Ma. Garcia, justice, \$67.75; Apolonio Chavez, probate judge, \$150.

Crofton's Narrow Escape. Col. R. E. Crofton, commandant of Fort Sheridan, near Chicago, and well known throughout the west as formerly commandant at Fort Stanton, New Mexico, and Fort Lewis, Colorado, was shot and wounded Thursday afternoon at Fort Sheridan by First Lieut. S. S. Prague, company F, 15th infantry. At 4 o'clock while the colonel was reviewing the dress parade, Lieut. Prague, who had been confined in the hospital, came upon the grounds and deliberately fired three shots at his superior officer. The first shot went wide of its mark, the second went through the colonel's coat and the third grazed his abdomen.

Prague would have fired again had not the colonel jumped from his horse and grappled with him. Lieut. Prague had been drinking and was practically a maniac. Being so much younger and stronger than Col. Crofton, the latter was no match for him and was thrown to the ground before Lieut. W. H. Flow and others rushed to his rescue and disarmed the would-be murderer. As soon as Lieut. Prague was subdued an ambulance was called to remove the wounded colonel, and Prague himself was escorted to the guard house, where he is now being closely watched.

Why the young lieutenant should have attempted to take the life of his colonel seems to be something of a mystery, though it is known that he is hardly responsible for his actions. Mr. Prague is addicted to drink, and has on two occasions been an inmate of the asylum for drunkards at Dwight.

COURT TRANSACTIONS.

Disposition of Cases in U. S. Court of Private Land Claims—Brief Session of Supreme Court.

In the United States court of private land claims, this forenoon, an appeal was granted to the supreme court in the matter of the Felipe Tafuya grant, rejected at the last term.

The court took the matter of the approval of the survey of the Juan Lobato grant under advisement.

The Rancho del Chino Tejano grant case was submitted on briefs by Mr. J. H. Kneidel for petitioner and Mr. S. Burkhardt for the United States.

IN THE SUPREME COURT. The supreme court met at 10 o'clock this morning with Chief Justice Smith presiding and Associate Justices Hamilton, Banta and Laughlin present. As the court room was uncomfortably cold, a recess was ordered until 2 p. m. Meanwhile arrangements have been made to warm the room.

TO BEAT THE RECORD.

The New A. T. & S. F. Train Service—A Fine New Flyer Over Mountain and Plain.

Beginning October 29 the Santa Fe route will inaugurate a new fast limited passenger service between Chicago and southern California. It will leave Chicago daily at 6 p. m., and Los Angeles daily at 8 p. m. Westward the speed of these flyers will average forty miles an hour. From Chicago to Los Angeles the trip will consume three days, which is faster by half a day than ever before accomplished by any transcontinental road.

This train will bring passengers from Chicago to Santa Fe in forty and one-half hours, and from Los Angeles to Santa Fe in thirty-eight and one-half hours, passengers from both trains meeting the branch train at Lamy and reaching here at 10:30 a. m.

The equipment of the California Limited will be new and luxurious. It will consist of a reclining chair car, two Pullman palace sleepers, dining car, baggage and express, vestibuled throughout and running solid from Chicago to Los Angeles, and once a week a Pullman compartment sleeper will be added.

Only first-class tickets will be honored, and no passes "go."

A Different Policy Wanted. If building lots on Don Gaspar avenue between the capitol grounds and Ramona school could be had at anything akin to a reasonable price, the NEW MEXICAN is assured by three or four homeless citizens that they would purchase and build residences thereon costing from \$2,000 to \$5,000. But the trouble is that the owners and agents of this property are most unreasonable in their demands. They overlook the fact that half a dozen dwellings of the value and style contemplated would more than double the market price of their adjacent holdings. It is this narrow, biggared policy that prevents the modern building up of Santa Fe.
