## RAILWAY LABOR UNIONS MAIL STRIKE BALLOTS

### King Alexander, Jugoslavia, Weds Princess Marie Tomorrow

#### PREPARATIONS COMPLETE FOR GREAT EVENT

Princess is Greeted by Mayor of Belgrade Who Follows Time Honored Custom

GROOM IS NATIVE OF SERBIA  
Holds Respect and Esteem of the Balkans Through Efforts To Unite Serbs-Croats

(By Associated Press) BELGRADE, June 7.—Princess Marie of Rumania, is making final preparations for her marriage tomorrow to King Alexander of Jugoslavia. When she arrived here yesterday, she put her foot on the soil of her future kingdom, she was met by the mayor of Belgrade, who, in token of friendship and loyalty, presented her with bread and salt.

King Alexander of Jugoslavia, second son of the late King Peter of Serbia, became heir apparent to his father's throne in 1909 when his elder brother, Prince George renounced his rights as a sequel to a bitter press campaign in which an almost endless list of outrages were charged against him. The campaign was intensified by charges that the royal youngster had murdered one of his servants during a fit of anger.

Serbia, upon its liberation from the Austrians, became the predominant state in the organization of Jugoslavia, therefore it was certain that its Prince Regent, as Alexander had been designated when King Peter retired in 1914, was headed straight for the new throne.

He had won the respect and esteem of the Balkans in many ways, but chiefly through his efforts to unite the Serbs, Croats and Slovenes, formerly under the Austrian yoke. These endeavors won him the title of "Peacemaker." His action in appointing governors for Serbia, Montenegro, Slavonia, Bosnia, Dalmatia and Croatia also was warmly approved.

King Peter died in August, 1921, at the age of 76, and Alexander, then suffering from an attack of appendicitis in a Paris hospital, was proclaimed his father's successor at Belgrade.

King Alexander was born in 1888. As a youth he was frail and sickly, but his career began to give more promise after several years of hard campaigning at the head of Serbia's army. His education was completed at Petrograd and his first real military training was obtained in the Balkan war of 1912.

Throughout the World War he was devoted to the allied cause. It was Alexander who ordered the mobilization of Serbia's army and personally led it into battle. He was severely wounded in the fighting around

#### SPOUTERS ARE ASSEMBLED TO TALK BUSINESS

Associated Advertising Clubs of World Hold Sway For Five Full Days

(By Associated Press) MILWAUKEE, Wis., June 7.—The largest number of speakers ever brought to a single convention in Milwaukee, of national and international reputation, totaling 200 prominent men, will address the Associated Advertising Clubs of the World in their convention here June 11 to 15, inclusive.

The convention will be broken up into departmental sessions rather than general meetings. It is in the departmentals that the men who make business move, will exchange views on a given set of conditions, it was said by Homer J. Buckley, chairman of the program committee.

Two of the departments which will play an important part in the gathering will be those of general advertising and community advertising. Leading civic workers throughout the country will address these meetings.

For the general program Sunday afternoon, June 11, the principal speakers will be Sir Charles Hignam, member of parliament and a leading advertising expert of the British Empire; also Dr. Charles Aubrey Eaton, president of the American Educational Association.

At the Monday and Wednesday general sessions and discussions will center around the power of advertising to move the \$32,000,000,000 worth of manufactured and farm products in the United States and the vast amount of world products.

#### BOY MURDERER MEETS DEATH ON GALLOWS

LONDON, June 7.—Henri Jacob, 19 years old, pantry boy, found guilty of the murder March 14 of Lady Alice White, was executed today at Pentonville prison.

Belgrade before his troops were forced to evacuate the city, and barely escaped capture at Nish, where he set up a capital for a brief period before the Austrians entered.

Several attempts were made to assassinate him during the regency and after he became king. The latest of these occurred in June, 1921, and resulted in the death of one person and the wounding of six others. Some 14,000 persons were arrested as a sequel of the plot.

The young Princess Marie, called the prettiest princess in Europe, is only 22 years of age. She is the second daughter of King Ferdinand and Queen Marie of Rumania, and a not well known for the reason that her life has been spent quietly at home, except for a short period in England, where she attended school.

Her mother, born an English princess, has one of the most interesting personalities to be found among the crowned heads of Europe. While she has been charged with attempting to build up a tremendous power by marrying her children to the greatest political advantage, she has stated emphatically that the betrothal of Marie was the result of a genuine love match.

#### PEOPLE DESERT BELLECK FEAR BEING KILLED

Cardinal Logue, Primate of Ireland, Is Held Up By Ulster Constables

AUTOMOBILE IS SEARCHED  
Church Papers are Scrutinized Following Which Party is Allowed to Proceed

(By Associated Press) BELFAST, June 7.—Nearly all men combatants have left the Belleck district in the northwest of Formanagh, and cattle are wandering aimlessly over the countryside. Only Irish republican army patrols from Port Seen are making about it. It is the growing belief that political influences are asserting themselves in the situation in view of the London conferences and protest over the Pettigo incident by Michael Collins, head of the southern government.

BELFAST, June 7.—Cardinal Logue, primate of Ireland, while auto-mobiling with Archbishop O'Connell, was held up at Lisnadilla, near Armanagh, by a party of Ulster special forces, who intimidated their intention of searching the car. The cardinal objected and demanded their authority, whereupon, according to a Dunalk report, one of the special forces whipped out a revolver and said: "That's my authority." The automobile was afterwards searched and church papers scrutinized. The car was then allowed to proceed.

#### MEASUREMENTS OF TALK ARE NOW OPPOSED

Use of Telechronometer Disliked by Residents of Everett and Other Cities

(By Associated Press) SEATTLE, June 7.—Keen interest is being evinced in cities and towns of Washington in the fight of the city of Everett against the continued use of the telechronometer, an instrument recently experimentally installed on telephones of that city by means of which time is consumed in the use of the telephone is measured and the subscriber charged by "telechronometer" rather than a flat rate. The hearing by the department of public works on the city's application for an order prohibiting the use of the instruments adjourned yesterday to be continued later after the valuation of the Everett system is compiled.

#### NO REDUCTION NAVAL FORCES IN SHIPYARDS

Work Will Proceed at Present Rate Under Arms Conference Agreements

(By Associated Press) WASHINGTON, June 7.—Work on all naval vessels permitted the United States under the arms conference treaty would proceed at about the present rate with no reduction of forces at any of the private or government yards under the revised naval appropriations bill completed by the senate appropriations committee.
