MINING LAW.

Laws of Congress Governing the Location, Holding and Working of Mining Claims Upon the Public Domain.

Below will be found an abstract of the Mining Laws of the United States, as passed by Congress and approved May 10, 1872. These are the last, and hence the only mining laws of general interest and force, with the single exception of a portion of section 5, each covering a special locality, and which were located prior to the passage of the general mining law. The Act amending the section alluded to will also be found, following the general law modifying section 5, so that a claim located prior to May 10, 1872, is not subject to relocation until June 15, 1874.

ACT TO PROMOTE THE DEVELOPMENT OF THE MINING RESOURCES OF THE UNITED STATES.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That all valuable mineral deposits in lands owned by the United States, both surveyed and unsurveyed, are hereby declared to be free and open to exploration and location by any person who may wish to do so, and that the same are applicable and not inconsistent with the laws of the United States.

Section 1. That mining claims upon veins or lodes of quartz or other rock in place bearing gold, silver, copper, lead, zinc, iron, tin, molybdenum, or any other mineral, shall be made in accordance with the provisions of this act, and no other law shall be construed to apply to such claims.

Section 2. That where a tunnel is run for the purpose of exploring for veins or lodes, the owner of the tunnel shall have the exclusive right of possession and enjoyment of all the surface included within the lines of such tunnel, and of all veins, lodes, and ledges throughout the entire depth, the top or apex of which lies within the surface of the tunnel.

Section 3. That the miners of each mining district may raise a mineral claim, and the same shall be subject to relocation in the same manner as if no location of the same had ever been made.

Section 4. That where a tunnel is run for the purpose of exploring for veins or lodes, the owner of the tunnel shall have the exclusive right of possession and enjoyment of all the surface included within the lines of such tunnel.

Section 5. That all valuable mineral deposits in lands owned by the United States, both surveyed and unsurveyed, are hereby declared to be free and open to exploration and location by any person who may wish to do so.

Section 6. That a patent for any land claimed as a lode or vein shall be subject to relocation in the same manner as if no location of the same had ever been made.
