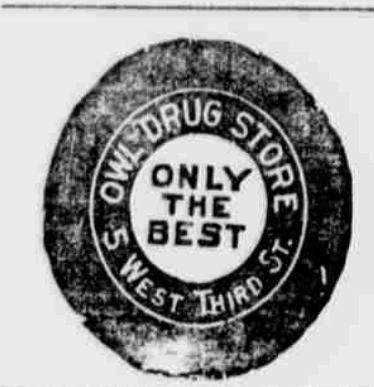
HEAR ARGUMENTS ON COMMON CARRIER LAW
SOLICITOR DANIEL ARGUES AGAINST PIPE LINES BEFORE SUPREME COURT.

WASHINGTON, Oct. 15.—Solicitor General Davis argued before the supreme court today in support of the common carrier's position in declaring the "pipe line law" unconstitutional. He contended that the law was passed in 1906 to free the country from the oil monopoly and that a court order for the dissolution of the monopoly, ordered since furnished no reason for annulling the law. He argued that it was just as proper for the government to impose financial loss upon pipelines for requiring them to carry their competitors' oil at reasonable charges as it was for the states to pass laws which resulted in losses to farmers.

John G. Milliken for the Oil Oil company, the Standard Oil company of New Jersey and the Standard Oil company of Louisiana, argued that the government had no power to say that a company which had built its pipeline in its own property for its private use, should be a common carrier and subject to regulation in the interstate-commerce commission.

The solicitor general told the court, however, that it would be to enforce the law on pipelines only to farmers holding themselves out as common carriers because of the devices adopted by the companies. He said the pipe line of the Ohio Gas company furnished an example of the words of "Pennsylvania" from which both the Standard Oil company of New Jersey operated a pipeline in New York harbor. A life clause of ownership was effected, he said, in the words of Louisiana, between the Standard Oil company of Louisiana and the Pacific Oil & Gas Co.
