The lynching in Wewoka this week is still another blotch on the historic pages of this state and an open insult not only to the governor of Oklahoma but to every true hearted citizen of the state.

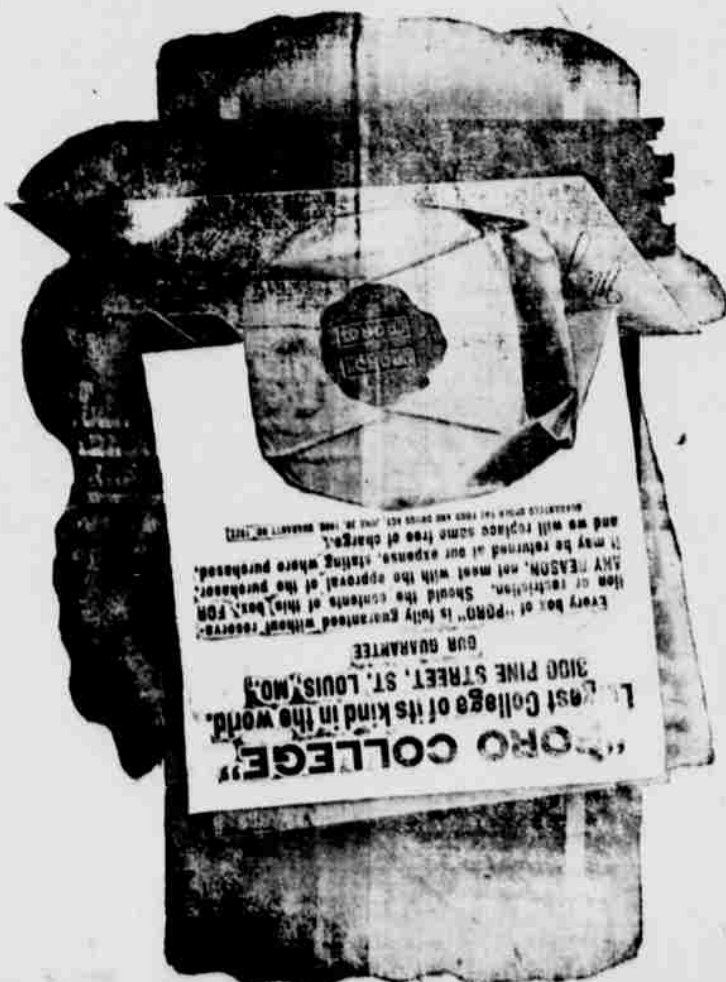
