

Proceedings Of County Court

In the County Court of the State of Oregon, for Wallowa County. Wednesday, Jan. 6, 1909.

Be it remembered, that at a regular term of the county court of the state of Oregon, for the county of Wallowa, begun and held at the court house in the city of Enterprise, in said county and state, on Wednesday, the 6th day of January, A. D. 1909, the same being the first Wednesday of said month and the time fixed by law for holding a regular term of said court, when were present: The Honorable J. B. Olmsted, county judge; Sam Litch, commissioner; W. G. Locke, commissioner; W. C. Boatman, clerk; Edgar Marvin, sheriff.

When on Wednesday, the 6th day of January, A. D. 1909, on the first judicial day of said term, among others the following proceedings were had, to-wit:

In the matter of road petition of Eugene Hafer, et al. Now at this time Eugene Hafer and others petition the court praying for the location of a county road, comes on to be heard, and it appearing to the court that said proposed road is in Wallowa County, state of Oregon, and that said petition is signed by 12 or more freeholders of said county and state, residing in the vicinity of said proposed road and that the petition correctly describes the beginning, intermediate points and terminus thereof, and it further appearing to the court by affidavits filed therein, that due and legal notice of presentation of said petition to this court, notifying all persons that applications would be made by advertisement posted at the place of holding this court and three other public places in the vicinity of said proposed road and it further appearing that a bond conditioned according to law has been filed herein which bond is hereby approved. It is therefore hereby ordered that the prayers of said petitioners be granted. The road viewers are hereby ordered to view and lay out said road according to the day of —, and of their proceedings made due and legal return to the court at their next regular meeting.

In the matter of checking and approving road supervisors' reports: Now at this time the court proceeds to check, examine and approve all road supervisors' reports now on file with the clerk.

In the matter of approving the official bond of B. F. Miller, county assessor elect. Comes now B. F. Miller, who was duly elected county assessor at the preceding general election, and who has taken the oath of said office as provided by law, and presents to the court his official bond for approval, and the court having examined the same and being fully advised in the matter, it is hereby ordered that said bond be, and the same is hereby approved.

In the matter of the official bond of W. T. Bell, county treasurer: Now at this time W. T. Bell, county treasurer, presents the court with a new official bond in lieu of the one heretofore given and approved; the former bond was found defective. The court having examined the same and being fully advised in the matter, it is hereby ordered that said bond be, and the same is hereby approved.

Whereupon court adjourned until tomorrow morning.

RESTORATION TO ENTRY OF LANDS IN NATIONAL FOREST.
