**THE HOME DOCTRINE.**

The "Home Doctrine" that does more than any other one thing to build up the material prosperity of a community, is thus stated in Goodwin's Weekly:

Encourage every home enterprise. Take an interest in every industry. Invest liberally in the stock of faith and good will, and distribute it all over your city, in every factory, every work shop, every business house. It will pay you large dividends, and will cost very little. It can never depreciate in value. It will always be above par. Buy home made goods. Ask your merchants for them. Wear home made garments, eat home made articles of food, sleep on home made beds, read home made newspapers. In this way the money you spend is only loaned. It will come back to you again with interest. Praise your city—don't run it down. Stand by your merchants and manufacturers—they are the bone and sinew of your municipal structure. Stand by your churches and your schools—they are the hopes of your future. Stand by your press—it is the tireless sentinel that guards your interest.

The price of stumpage is constantly going up. This does not help the wages of labor in any way. It makes timber land higher, but the timber worker has no more to show for it. He is told that the price of labor depends upon the supply. If the land owners grab the timber and hold it out of use that makes jobs scarcer, wages lower and timber higher. Through the alchemy of modern commerce the wages the laborer don't get become the millions the land monopolist does get. Oregon has given its timber land for the most part to a lot of alien sharks, who might as well be English dukes, as some of them are, to whom we pay tribute. There is a string to every grant of land in all countries. That is the right of taxation. We will pull it in Oregon one of these days, says the Labor Press, as they are doing in New Zealand, and getting ready to do in England.

Dr. John McLoughlin and his work in aiding the early settlers at Oregon City will not be forgotten and by a decisive vote, this pioneer city has declared it will maintain the historic home of Dr. McLoughlin as a public monument to his work. This tribute to Dr. McLoughlin will meet with the hearty approval of all right thinking people everywhere.

Advertising a locally by means of a railroad folder is good and it is money well spent, but the town that advertises itself with a good local paper brings more attention to itself, dollar for dollar, than all the railroad pamphlets in the world.—Labor Press.
