LANDSLIDE FOR TAFT IN ALL PARTS OF NEW YORK

Waverly, N. Y., Oct. 31.—A big crowd of New Yorkers and Pennsylvanians greeted Taft here today and paid the respects of the two commonwealths to the candidate. This is the first time the people of this section have been given an opportunity to hear either of the presidential candidates and they came a long ways to be present at the meeting. Members of the Taft party expressed their belief today that the state is no longer doubtful. They point to the crowds that are greeting the candidate as evidence that Republican enthusiasm has been awakened through the state by Taft's tour. They declared that New York, which has been thoroughly canvassed, will give the Republicans an unprecedented victory.

The unsettled feeling of the New York Republican managers is manifest no longer. One of the leaders here declared that the result is due to the personality of the candidate and asserted that he has shown himself to be a great campaigner.

The tour today closes the New York campaign and the interest in the closing days is greater than has been known in a long time.

CLAIMS BRYAN WILL GET 295 ELECTORAL VOTES

Chicago, Oct. 31.—John E. Lamb, of the Democratic national committee, issued a forecast today, claiming 295 electoral votes for Bryan. He declared that, besides "the solid would go for Bryan: Kentucky, Maryland, Oklahoma, Indiana, Ohio, New York, Kansas, Montana, Nevada, New Jersey, Nebraska and South Dakota. This would give Bryan a total of 295 electoral votes. He conceded that Taft would carry Maine, Massachusetts, New Hampshire, Pennsylvania, Vermont, a total of 78 electoral votes. He calls the others doubtful.

SAYS TAFT AND STANDARD SOLID

New York, Oct. 31.—Charging that the Republican party has conspired with the corporate interests of the country to secure the election of Taft by a deal through which money was given for promises by Republican party managers that the \$29,000,000 fine will be "fixed up," National Chairman Mack, of the Democratic party today gave out a statement, commenting on John D. Rockefeller's support of Taft. He said:

"The Standard Oil has landed where everybody knew it would land. Mr. Rockefeller held back for a bargain, and got what he wanted. The deal will be good for over 100,000 more votes for Mr. Bryan in quarter of a million more votes in the country.

"The Republican party will get a good big 'can' through the deal. I can't specify the exact amount, but it is certain that when the bargain was struck, both sides got what they were after. The Taft managers got the money, and the Standard Oil got the promise.

"The \$29,000,000 fine will be fixed up somehow, and several other issues also. And the question arises, is Taft good to be with Rockefeller for the next few years or with Roosevelt? The Standard Oil is with Taft, and not with Roosevelt.

"I have it on good authority that the Republican national committee has sent \$200,000 into the state of Indiana, and if necessary will send more. More than that has been sent into Ohio, and a similar amount will be put out in New York state.

"They have more than \$3,000,000. One million dollars is to conduct the campaign and the \$2,000,000 is for bribery. But I don't think that the Republican party can buy Mr. Taft's election. You can't buy elections any more."

For governor Cosgrove (Rep.) and Pattison (Dem.) are running.

West Virginia.—The Republicans admit a falling off in the vote because of a party row on the gubernatorial, but confidently claim the state for Taft. The result of the state election undoubtedly will be close. The industrial interests are making special efforts in behalf of Taft. The Democrats claim Bryan will run practically even with the gubernatorial candidate, and therefore carry the state. For governor Glascock (Rep.); Bennett (Dem.).

Wisconsin.—A Republican majority seems assured, notwithstanding the possibility of disaffection of the La Follette Republicans because of the defeat of the Wisconsin's senator's pet resolution at the Chicago convention, and at the state convention at Madison. For governor Madison (Rep.); Alshwerd (Dem.). In the congressional fight the Republicans will attempt to regain the third district, where Murphy is running against Kopp (Rep.). Senator Stephenson (Rep.), who was named at the primaries to succeed himself undoubtedly will be chosen since the legislature will be very strongly Republican.

Wyoming.—The Mormon vote holds the balance of power. Factional fights in several sections have embarrassed the Republicans. The result is uncertain, but the chances at present seem to favor Taft.

Rhode Island.—The labor vote is an unknown quantity, although it seems practically certain that the Republican national ticket will carry. The result as to the state ticket is in doubt. For governor Arnold (Dem.); Pothelk (Rep.).

South Carolina.—As usual the nor Ansel (Dem.) will be elected by the usual majority.

South Dakota.—The county option and other local issues are likely to reduce the usual Republican vote. The gubernatorial contest is in doubt. The Republican candidate, strongly favoring prohibition, is likely to have a close race. For governor Vessey (Rep.) and Lee (Dem.).

Tennessee.—The usual Democratic majority is expected. For governor Patterson (Dem.); Tileman (Rep.).

Texas.—A split on prohibition in the southwestern part of the state is counted on by the Republicans to reduce the usual Democratic majority. The former are centering their ear and Burleson (Dem.) in the tenth and fifteenth districts. For son (Rep.).

Utah.—The Mormon vote cuts the biggest figure in this state. It is expected to give Taft a good margin.

Bryan will, however, poll a big vote of the "American" or anti-Mormon party, which is antagonistic to Roosevelt and Taft because of an alleged agreement with Senator whereby their influence was to be used in retaining him in the senate, for which, it is alleged, Smoot was to deliver the Mormon vote. The gubernatorial contest is in doubt, with the following candidates: Spry (Rep.); Knight (Dem.); Street, (American).

Chicago, Ills., Oct. 31.—The greatest political rally in the history of Chicago is planned for tonight when William J. Bryan and Adelaide Stevenson, Democratic candidate for governor of Illinois, are to speak here. A cavalry parade and tons of red fire are features of the reception that is planned when Bryan arrives here from his tour of Northern Indiana.

Bryan is to be met by the "Stockyards Cavalry" of 800 mounted workmen and escorted through blocks of red fire to the Morse Pavilion at the stockyards, where he is to make his first address of the evening. A large number of bands have been engaged for the parade.

Three other monster meetings have been planned, at which Bryan is to speak. Simultaneously Stevenson will speak at several meetings on the South Side, and Governor Deneen will also speak on the South Side.

San Jose, Cal., Oct. 31.—Without the alternative of paying a fine, Peyster W. Metcalf, son of secretary of the navy, Metcalf, was sentenced to 20 days in the county jail today by Judge Brown. The charge against young Metcalf was battery on a man named Bylesworth, who was struck by the automobile which Metcalf was driving while intoxicated.

Metcalf had been arrested several times for petty misdemeanors.
