CHARGES \$20,000 WAS OFFERED TO FREE THAW

PACIFIC MAIL TO LEAVE ESPEE

SAN FRANCISCO, Cal., Feb. 27.—Coming as one of the direct effects of the dissolution of the Southern Pacific-Union Pacific merger, the formal separation of the Pacific Mail company and the San Francisco and Portland Steamship company will be effected here tomorrow. R. P. Seherwin, general manager of the Oregon-Washington Railway and Navigation company were in conference here all day perfecting the dissolution plans.

Although details of the dissolution plans have not been given out, it was expected that G. L. Blair, freight traffic manager, will become general manager of the divorced San Francisco and Portland company, with headquarters in San Francisco.

LUMBER FIRMS LOSE TIMBER

PORTLAND, Or., Feb. 27.—United States Attorney McCourt today made public decisions by the United States circuit court of appeals at San Francisco, handed down Tuesday, which upheld the government in its contentions that eight timber claims held by C. A. Smith and others, and four claims now in the possession of the Booth-Kelly Lumber company of Eugene, Or., are held illegally.

All the lands involved are in Lane and Linn counties, Oregon, and are estimated to be worth \$150,000.

The original suits were filed in 1908 and were based on the allegation that the patents to the land had been obtained fraudulently.

LAZY HUSBANDS TO WORK STATE ROADS

OLYMPIA, Wash., Feb. 27.—Governor Ernest Lister today has the power to make all lazy husbands who willfully refuse to support their families, go to work. The senate unanimously passed the house bill Wednesday, which makes lazy husbands amenable to the law. The bill provides that errant husbands can be put on county road work for which their families are to get up to \$1.50 per day. The term of imprisonment is fixed by a maximum of one year. The bill also permits such husbands to be fined, money to go to the deserted family. The maximum fine is \$1,000.

RAILROAD LOBBY WINS IN HOUSE OVER GOVERNOR

SALEM, Or., Feb. 27.—A red hot message from Governor West produced quick action in the house yesterday on S. B. 293, the Portland public levee measure.

Coupled with the activity of lobbyists for the Southern Pacific and the fact that the bill has reposed in the house since February 13, and has twice been sent to the ways and means committee, of which Carkin is a member, a well defined suspicion has grown up that it has been the intention not to let it come to vote at all.

Following the message from the governor, however, the bill was quickly reported out by the ways and means committee.

The governor's message read: "Notwithstanding the fact that this is a measure wholly in the interest of the people, it appears to have had hard eluding from the start. The corporation lobby has been quietly and secretly at work throwing every obstacle in its way—and they have played their game well. In the name of the long suffering public I call upon every man in the house who claims to be a friend of the taxpayer to be on the alert and see that this bill is not permitted to die the death which the corporation lobby has so ably prepared for it."

The legislature, however, adjourned without action.
