MEDFORD ARMORY BILL IS PASSED CARRIES \$20,000

SALEM, Or., Feb. 27.—The Medford armory bill passed the senate last night. It carries an appropriation of \$20,000 available when the city of Medford and Jackson county have each appropriated \$20,000. It differs from the other armory bills, in that the state stands only a third of the cost instead of half. Credit for passing the bill is due to Carlin and Westerlund, whom Roames accused on the floor of the house of double-crossing him on the Rogue river fish bill for armory support.

The Hoskins bill prohibiting the sale of liquor outside of incorporated towns has today reached the governor amended so as to exempt from its provisions clubs not conducted for profit and beach resorts hotels which have a capacity of 50 or more.

Senator Hatton's bill, under the provisions of which any school district in the state may vote on the question of supplying free textbooks when the school board so orders, has today been passed by the house.

RIOTING MARKS STRIKE OF RUBBER WORKERS

AKRON, Ohio, Feb. 27.—Stirred to action by rioting which marked the strike here of thousands of workers of the big rubber companies which make automobile tires here for the whole country the state board of arbitration today is planning to confer with both sides of the dispute in an endeavor to effect a settlement.

The state board's first movement came when it conferred with Chairman Pollock of the strikers' scale committee to secure an analysis of the worker's position regarding arbitration. It is hoped to induce the manufacturers to meet officials of the Industrial Workers of the World, who are managing the strike, but the prospect of peace in that way is doubtful.

TURKEY AGREES TO PEACE TERMS

LONDON, Feb. 27.—Dispatches received here today from both Constantinople and Sofia confirm the report that Turkey has signified her willingness to surrender Adrianople to the Balkan allies and stands ready to negotiate for peace on this basis.

The Turkish government, as St. Petersburg declared, already has solicited the good offices of Russia and the latter government, it is said, has transmitted the Turkish proposals to the Bulgarian government.

Dispatches from Sofia stated the Bulgarian council met today to consider the proposal.

WILSON'S OFFICE TO BE IN CAPITOL

TRENTON, N. J., Feb. 27.—President-Elect Woodrow Wilson today said he intended to occupy the "President's room" at the capitol in Washington every day during the extra session of congress. He expressed the belief that the nation's executive should be close to the members of the legislative body.

President-Elect Wilson has confirmed the appointment of Charles Swen, 20, of Newark, N. J., holder of the world's stenographer record for speed and accuracy, as his private stenographer.

WILLIAM WILSON TO BE IN CABINET

WASHINGTON, Feb. 27.—Friends of President-Elect Woodrow Wilson today say that Congressman William Wilson of Pennsylvania, former secretary treasurer of the United Mine Workers of America, is to be secretary of the new department of labor, created under the terms of the Borah bill, just passed. It is also believed here today that Louis Brandeis of Massachusetts would be named secretary of commerce instead of attorney general.

TEN THOUSAND CRY "SAVE ME"

NEW YORK, Feb. 27.—Ten thousand telegraphed pleas of "Save me! Save me!" from New Mexico alone swamped Dr. Frederick Friedmann, the young Berlin scientist, who is convinced that he has discovered a specific cure for tuberculosis. Deeply agitated by the deluge of letters and telegrams, Dr. Friedmann has employed a large force of assistants to aid in the clerical task of responding in some form to the requests.

Dr. Milton Foster of the government health and marine hospital service this afternoon conferred with Dr. Friedmann to complete final details for the government test of the alleged cure.

Hundreds of tuberculosis sufferers today called at the Waldorf Astoria hotel to see Friedmann but they were barred by hotel attendants. The physician, however, would not send them away without hope.

PARIS, Feb. 27.—Declaring \$70,000,000 is due him from Japan for selling Russian military secrets to that country during the Japanese-Russian war, Russian Baron Ygor Tillynsky is in Geneva today prepared to press his claims, according to a dispatch from that city. It is stated both the Russian and Japanese governments will investigate the matter.
