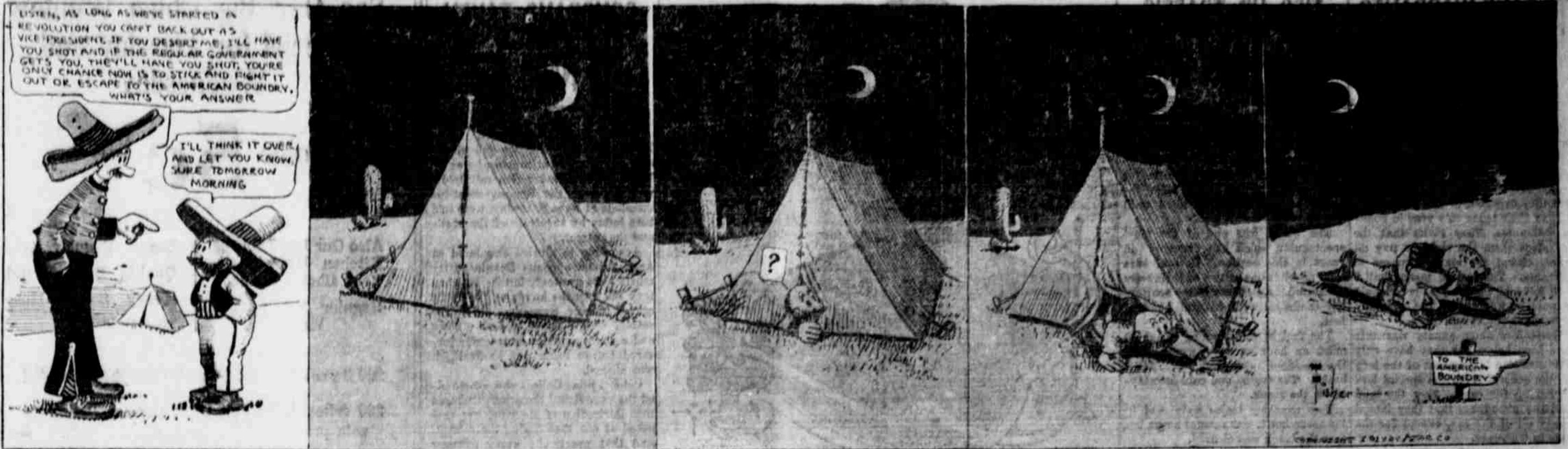


Jeff Thinks a Live Coward Is Better Than a Dead Hero
