

CITY ATTORNEY TO BE REMOVED BY COUNCIL TONIGHT

The city council will probably play to a crowded house tonight, the chief attraction to be offered the public being the removal of City Attorney Boggs. According to the councilmen today Boggs will be removed by unanimous vote.

A petition has been circulated by Boggs' friends asking the council to retain him. The petition also pledges all of the signers to be at the council rooms tonight, and to aid in starting a recall against the councilmen who vote to oust Boggs.

Boggs was asked last Friday to resign which he flatly refused to do. Since then he has been busy having pressure brought to bear on the councilmen to change their minds but in this he has been unsuccessful as the councilmen believe that he must be removed in order to restore harmony. The councilmen believe Boggs responsible for much of the discord between their body and the mayor.

Considerable other business is to be transacted by the council.

MEXICO CITY, April 1.—Unconfirmed reports reached here today that Zapatistas have shot to death Pascual Orozco, senior and several of his companions. It is stated that General Orozco junior is heading an expedition into Morelos to avenge the death of his father.

EXTENSION OF FRANCHISE ASKED DEAL IS PENDING

A 90 day extension of time for the construction of a trolley line in this city has been asked of the city council and will in all probability be granted. The extension is asked in order to allow a local syndicate, headed by F. B. Waite, S. S. Bullis and W. I. Vawter to make certain financial adjustments.

The 90 day limit imposed by the first franchise will expire within the next two weeks. When the franchise was first granted it was given to the M. T. Minney company who later turned it over to Mr. Waite and associates. This company is negotiating with an English syndicate which plans extensive development in the valley. Their engineer has been over the ground and has made a favorable report to them. The extension of time is asked in order to complete the negotiations.

100 TO 1 SHOT WINS LINCOLNSHIRE RACE

LINCOLN England, April 1.—Quoted at odds of 100 to 1, A. B. Martins Berymon today won the famous Lincolnshire handicap. W. D. Walker's St. Cuthbert finished first, but was disqualified, and Berymon, which ran second, was declared the winner.

E. Martin's Junior ran third in the race, but was finally placed second, and Sir William Nelson's Grammont third owing to the disqualification of St. Cuthbert.

PERU DEAD BROKE SAYS MERCHANT

SAN FRANCISCO, Cal., April 1.—"Peru is dead broke."

That is the declaration made here today by R. T. Sparks, head of a big mercantile house in Lima, who is visiting in San Francisco.

Sparks declares the last president of Peru left office without accounting for \$75,000,000 which was supposed to be in the national treasury. The new president wanted to borrow \$5,000,000 to tide the country over until the next tax harvest. The members of the chamber of deputies all wanted a special remuneration to vote for the loan. They were promptly "fired" through a special election and a new chamber is now being voted for.

The country will secure no relief until June. Until then it must subsist on bread and water, governmentally speaking.

DIRT TRAIN PLUNGES THROUGH AN OFFICE

PORTLAND, Ore., April 1.—H. L. Idelman, a real estate dealer, had a narrow escape from death or injury, when a dirt train of eight cars broke from its moorings on Hawthorne avenue and dashed into the building in which his offices are located. Idelman had just made his way to safety when the office was struck. Nominal damage was done.

\$50,000 FOOD AND MONEY SENT EAST

PORTLAND, Ore., April 1.—It was estimated today that provisions valued at more than \$15,000 had been shipped from Oregon to the flood sufferers of Ohio and Indiana. The cash contributions in Portland totaled \$23,000 today.

SAN FRANCISCO, Cal., April 1.—Announcement that he will not again accept the post of ambassador to Japan, even if it is tendered him by President Wilson, was made here today by Larz Anderson, who for a few months was America's diplomatic representative at the court of the Mikado.

Anderson, who is here preparatory to returning to his home in the east, declared he had resigned from the diplomatic service for all time. Before going to Tokio, Anderson was United States minister to Belgium.
