

CITY DADS WORK WITHOUT DISCORD; BOGGS REMOVED

A gathering of citizens which jammed all available standing room in the council chamber, overflowed to the corridors and stairs outside and even extended to the sidewalk last evening witnessed the city council, about which so much of turmoil and discord has been reported recently, transact a great amount of city business without a single discordant note, or show of jangle. The councilmen and mayor had no words of anger to hurl back and forth but all seemed to work together for the common good. Even the removal of the city attorney which, it was reported, would loose the dogs of war, passed without the semblance of discord and by a unanimous vote. The crowd which had gathered in the expectation of verbal fireworks was disappointed in that respect but agreeably surprised by the manner in which the city dads, transacted business of import to the welfare of the community.

O. C. Boggs, city attorney, was removed, a unanimous vote being cast. The only remarks which followed a motion to that effect by Councilman Summerville, were by Councilman Mitchell who prefaced his vote with a few explanatory words. He stated that Boggs, in his mind, was an erector of discord, but still he would have preferred giving him a longer period in which to prove his worthiness or unworthiness. However, he stated that he would vote with the remainder of the council in the spirit of harmony. Incompetency was the ground upon which Boggs was removed.

Previous to the taking of the vote a petition signed by 40 or 50 citizens was filed asking that Boggs be retained. Following the taking of the vote city business was resumed without interruption or discord. Boggs continued to fill the office of city attorney throughout the evening.

A letter was read from W. I. Vawter in which an extension of 90 days was asked in connection with the trolley line franchise. Mr. Vawter stated that he was unable to attend this meeting. The matter was referred to a committee of the whole to meet at such time as possible for Mr. Vawter to be present.

Bids were received for the laying of sewers, a contract being awarded Chigreen brothers. Bids for paving were laid over until Friday evening when a special session will be held.

The matter of raising Bill Garrett's salary \$10 a month was reported upon favorably. Councilman Summerville suggested that this \$10 be deducted from Oweny Patton's salary but his motion did not meet with a second.

Councilman Campbell elicited the only applause of the evening when he made a plea for the purchase of sewer pipe at home providing the cost was not greater, in any degree, than for pipe purchased abroad.

A large amount of routine city business was transacted.

MARRIED NEGRO SWALLOWS POISON

ST. LOUIS, Mo., April 2.—Alleged to have been overcome by the stigma of being married to a negro, Mrs. Julia Gerhart, former wife of Chas. Gerhart, a wealthy St. Louis real estate operator, swallowed two ounces of bromidia at the home of Mrs. Timothy Cox, a friend, and is dead here today. She is alleged to have divorced Gerhart to marry L. W. Kellog, a negro butler in the Gerhart home.

Until her marriage to the negro, Mrs. Gerhart was prominent in St. Louis society.

According to Mrs. Cox, she often displayed her license to wed the negro and once exclaimed: "I do not care what becomes of me. I wish I were dead, for everyone knows I am married to a negro." Kellog admitted at the police station today that he was married to Mrs. Gerhart.

Mrs. Gerhart obtained the bromidia Saturday and lingered for some time after swallowing the substance.

MARSHFIELD CHAUFFEUR PLACED UNDER ARREST

MARSHFIELD, Ore., April 2.—Guy Greenleaf, a chauffeur, is under arrest today, charged with having contributed to the delinquency of Irma Knorr, aged fourteen, who committed suicide Monday after being chided by her mother for remaining away from home at night. Greenleaf was found in a cabin fifteen miles north of here.

COUNTESS MONTIGNOSO DENIES NEWSPAPER STORIES; COULD BE HAPPY IN AN ATTIC IF SHE HAD HER SON

The Countess Montignoso has denied most emphatically the fantastic stories of her affairs published recently in European newspapers. The Countess, who is living quietly at Brussels, has regained her health and attractive appearance and looks young, as she is no longer disturbed by her husband, being legally separated from him.

The Countess declared she has not written a word of the libretto of her husband's opera, has no intention of retiring to a castle in Austria or a convent in Italy; has not tried to commit suicide, has not been received again into the Church and has come to Florence only to see her boy.

"According to the newspapers," she went on, "I have committed suicide five times, been married ten times in two years—to an Italian officer, to a Florentine engineer, to a French aviator, to an American millionaire, to an Austrian count, to a professor of philology, to a Polish count, to a tutor, to a Russian nobleman and to a German lawyer."

The Countess Montignoso was the Princess Louise of Saxony, wife of the Crown Prince, when she was divorced by him in February, 1902. He has since succeeded to the throne of Saxony. There are six children, three sons and three daughters, the youngest of whom, Princess Anna Monica, was born in May, 1903, after her mother's rupture with the Crown Prince. The title of Countess Montignoso was given to the Princess after the divorce. In 1907 she was married to Enrico Toselli in London. She obtained a legal separation from him in 1911.

BLOODHOUNDS FIND BODY OF BANDIT

FRESNO, Cal., April 2.—After following a trail of fresh blood for two hours near here today, a sheriff's posse came upon the body of an unidentified and badly wounded man, who is believed to have aided in the murder of W. B. Quick, an aged grocer, here last night. It is believed the man accidentally shot himself in the leg while running away from the posse, and when unable to drag himself further, succumbed from loss of blood. His body was still warm when found.

Quick was killed in endeavoring to aid his son in resisting three armed yegmen who were robbing his grocery store. The other two yegmen eluded the police and posse.

WRIT OF REVIEW ASKED BY MILLAR

An application for a writ of review in the case of the City of Medford vs. George H. Millar, was made Tuesday afternoon by Attorney Newberry. The application will be granted and the case reviewed.

In this manner only is the case against George H. Millar open for appeal. In the review Judge Calkins will go over the law points involved and if he finds Mayor Eifert erred in his decision he will reverse the case.
