HYBRID TROUT EXPERIMENTED AT U. S. HATCHERY

Hugh Mitchell, superintendent of the Elk creek hatchery, states that rapid progress is being made on the repairs and enlargements at the hatchery. A new water wheel and troughs are being constructed, and two cement ponds, 50 feet in length by 8 feet and 3 feet deep are being dug. They will provide capacity for keeping a million trout fry to the fingerling state.

Mr. Mitchell passed through Medford from the Applegate station Wednesday and had eyed eggs that he is taking to the hatchery for experimental purposes. Steelhead had been crossed with cutthroat trout and also with silverside salmon. What the answer will be is awaited with interest.
