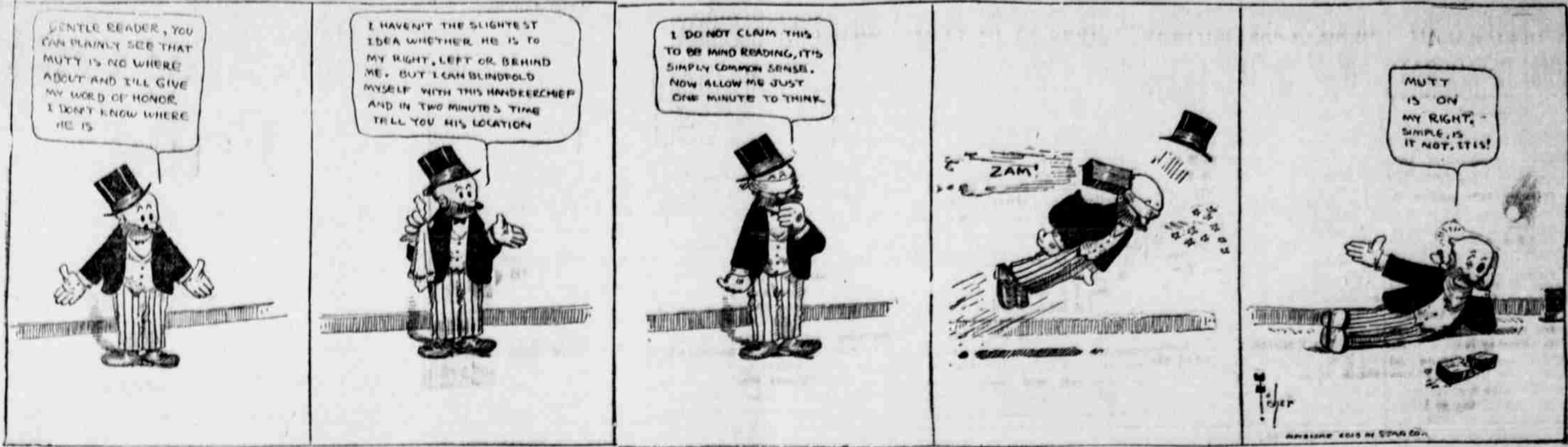


Jeff Evidently Took Mutt's Disposition Into Consideration

LANE FAVORS CONCRETE ROADS

EUGENE, Ore., April 18.—The recent discovery of a method of making cheaper concrete, announced by Dean E. H. McAllister of the college of engineering of the University of Oregon, has had the effect here of bringing the good roads movement down out of the skies, and there is now the immediate prospect that something will be done. The county court will undoubtedly act upon the following resolution passed by the county good roads association:

"It is resolved, that it is the opinion of the Lane County Good Roads association in meeting assembled on April 3, 1913, that the type of highway to be constructed in the Williamsite valley and which will demonstrate itself to be of superior value, is a concrete base from four to five inches in thickness, which base is to be covered with the bituminous asphalt from one to one and a half inches in thickness; and it is hereby respectfully submitted to the honorable county court of Lane county, Ore., that suitable experiments for the demonstration of the value of this road type should be made by building at least one mile this present year, and that it is the sense of this meeting that such road construction can be done at an expenditure of about \$6500 per mile exclusive of cost of grading the width of the highway to be about 16 feet."

The ability to lay concrete road in Oregon at such a comparatively low cost is due to Professor McAllister and the series of experiments to the credit of the state university, which resulted in the discovery of the use of "Puzozolan," a substance common in most parts of Oregon.

FIFTEEN CO-EDS ARE MAKING OWN WAY

UNIVERSITY OF OREGON, Eugene, April 18.—Fifteen "co-eds" at the University of Oregon are working their way through college independent of outside support. Many more are doing housework, sewing and like tasks for their board and room or for part of their funds.

"Tutoring, nursing and housework," says Mrs. E. L. Fletcher, secretary of the Y. W. C. A., "are the main sources of revenue for the women."

"There are many opportunities for attractive employment while attending college at Eugene and it seems a pity that any girl should give up the idea of going to college because of lack of funds. There are more positions than we are able to fill."

"The democratic spirit here is such that a girl who earns her own way is admired for her grit, and is not at any disadvantage among her classmates."

FIRE BURNS NEWSPAPER OFFICE, CALGARY, ALBERTA

CALGARY, Alberta, April 18.—At 1:20 o'clock this morning a fire broke out in the building occupied by The Morning Albertan Publishing Company and the MacLeod clothing store.

An effort made to save the subscription books and records of the establishment was practically successful. The Albertan is controlled by W. M. Davidson, who was at his desk when the fire was discovered and was one of the last to leave the building. The damage is estimated at \$300,000.

CIRCUS JARS SEWER REMEDYING DEFECT

The recent visit of the circus proved of a permanent benefit to the city in one respect at least, for, according to Street Commissioner Patton it remedied a sewer which has been giving trouble throughout the winter. The jar of loading and unloading from the cars dislodged debris which has been choking the sewer and now storm water escapes freely where before it backed up and flooded the street.

Throughout the winter a sewer at the Southern Pacific crossing on Main street has been choked. All efforts to clear it failed. It was believed that digging would have to be resorted to.

Then came the circus. The work of loading and unloading the cars happened to be directly above the seat of trouble. It is presumed that the jarring of the earth started the debris clogging the sewer and opened the drain. At least that is the way Patton does it out.

NEARLY HALF INCH OF RAIN DRENCHES VALLEY

Nearly a half inch of rain drenched the valley Thursday, the rain falling steadily throughout the night. A total of .42 of an inch was recorded. This brings the total rainfall during April with .8 of an inch above normal which is 1.26 inches.
