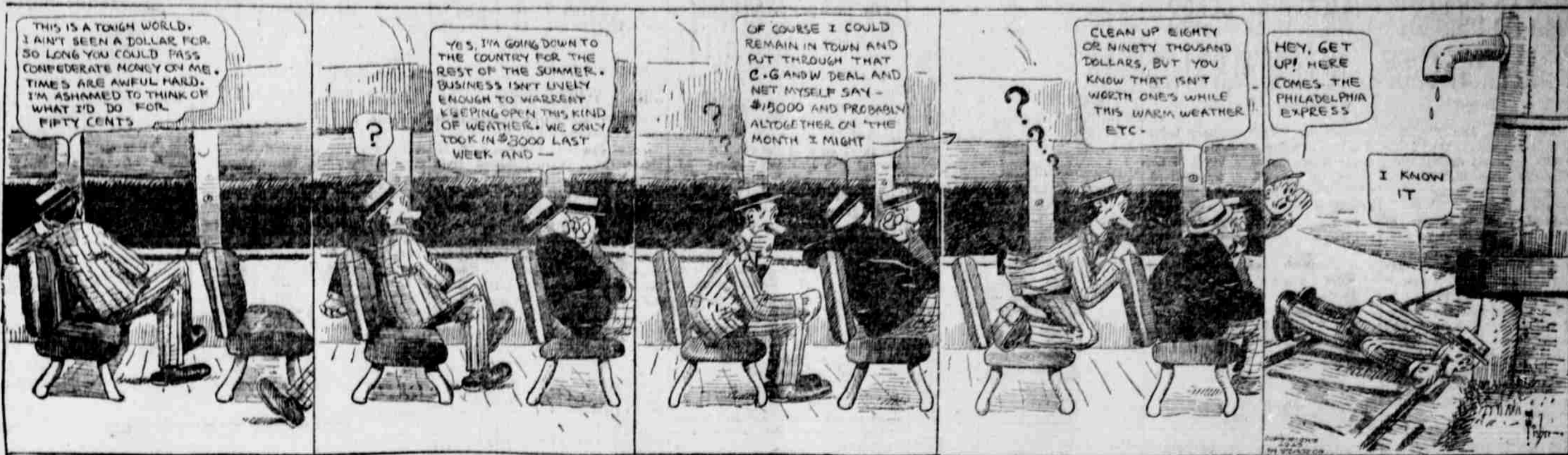

ORDINANCE NO. 767.

An ordinance authorizing the issuance of \$3750.00 of the Water Main Bonds of the City of Medford, Jackson county, Oregon, and directing the advertising of the same for sale in accordance with sections 116-127 of the charter of said city.

The city of Medford doth ordain as follows: Section 1. Whereas, the city of Medford has heretofore duly caused water mains to be laid in certain streets of said city, and has duly assessed the cost thereof to the property benefited thereby, in accordance with the charter of said city; and whereas, certain owners of certain pieces of property have assessed for such improvement in a sum exceeding \$15.00 have each made and filed applications to pay said several assessments in installments in accordance with section 120 of said charter, and, whereas, a water main lien docket has been duly made up in accordance with the provisions of said charter, and the total amount of unpaid assessments for such water mains, and for which application to pay under the provisions of said sections above cited has been made and filed as aforesaid, in the sum of \$3315.15.

Now therefore, said city of Medford doth ordain as aforesaid that there is hereby authorized to be issued bonds of said city in the total amount of \$3750.00 in denominations of \$250.00 and \$500.00, as may be convenient.

Section 2. Said bonds shall be in the following form: Serial No. No. CITY OF MEDFORD Jackson County, State of Oregon. WATER MAIN BOND. Know All Men By These Presents: That the city of Medford in the county of Jackson, state of Oregon, for value received, hereby agrees and promises to pay the bearer the sum of \$ in gold coin of the United States of America, on the presentation and surrender of this obligation on the first day of August in the year of our Lord one thousand nine hundred and twenty-three without grace, with interest thereon from the date hereof until redeemed or until the

time of the semi-annual interest payment next ensuing the publication of notice by the city of Medford that this bond will be taken up and cancelled, and that interest thereon will cease at the interest payment period next following such publication, at the rate of six per cent, per annum, payable semi-annually in like gold coin on the first day of February and the first day of August in each year, on the presentation and surrender of the proper coupons hereto annexed.
