

### NEED DELEGATION FOR GOOD ROADS EUREKA MEETING

Will the Pacific highway pass through Jackson county? Will it be along the coast of the Pacific, or will it be an interior highway? That is an important question.

On the 20th of this month the Pacific coast states will have a good roads meeting to be held at the city of Eureka, Cal. At this meeting the question of permanent location of the Pacific highway will likely be determined. There are many cities and towns in California, Oregon and Washington which have in view for their exclusive advantages the location of this highway.

It is known that there is a strong movement on foot to locate this highway on the coast. There is now a good road from the city of Red Bluff, Cal., to the city of Eureka. It is the intent of many to extend this south from Eureka, north to Crescent City, thence to Marshfield, both owning railroad terminus, thence to Newport, Toledo, Salem and Portland. It is stated that strong delegations will be on hand at this meeting from these cities to advocate the adoption of this route. In this event, if such a route is adopted, Siskiyou county, in California, and Jackson county, in Oregon, would be left high and dry.

Siskiyou and Jackson counties represent a larger population than all the counties between Red Bluff and Marshfield, has more natural mining, agricultural and horticultural resources, has the only scenic route between Portland and San Francisco, is better able and equipped to maintain such a highway than all the other counties. It is, as first contemplated, the only practical inland route available. It was never intended to be a coast route.

It therefore behooves Jackson county to get up and take notice. A strong delegate representing Jackson and Siskiyou counties, well backed by its citizens, should attend this meeting, should show up the mistake likely to be made in adopting the permanent highway.

### DELAY ACTION ON PROPOSED SHORT ROAD TO AGATE

A delegation of ranchers and interested property owners called on the county court Thursday in behalf of and against the petition recently presented asking a new road from Riverside drive at the Taylor place north of the Pacific & Eastern crossing, across Bear creek almost straight north to a connection with the present road that, turning west from the county road at the Pickel orchard, angles northwesterly around the bluff, skirting Bear creek to a junction with the Agate road. The proposed road will shorten the distance now traveled nearly two miles and make a short cut to Medford for residents of a large territory. It was petitioned for by over 200 citizens.

The viewers made a favorable report, placing the damages to be assessed at \$1300. The advocates of the road were represented by Attorney E. E. Kelley, the remonstrators by Attorney W. I. Vawter, who claimed damages for his clients exceeding \$7000.

No action was taken by the court other than a continuance. The county surveyor was instructed to secure estimates on the road to McAndrews ford or the Jackson bridge, instead of a new crossing, necessitating bridging Bear creek.

### HEAT WAVE GRIPS SACRAMENTO VALLEY

SACRAMENTO, Cal., Aug. 7.—Following yesterday's torrid wave, the local weather bureau today holds out little hope for immediate relief to heat sufferers in the Sacramento valley, and at 9 o'clock the temperature registered 84.

The mercury started soaring early yesterday and at 9 o'clock the thermometer stood at 86 degrees.

At noon it was 96 and at 2 o'clock Sacramento and vicinity sweltered with the mercury at 106, the hottest in eight years.

At Chico and other valley points in the heat zone as high as 108 was recorded at 3 o'clock yesterday.

### BLAME FRATERNITIES FOR SCHOOL SCANDLE

KANSAS CITY, Mo., Aug. 7.—High school fraternities are indirectly blamed here today for the death of Miss Meta Zook, aged 18 years, of the Westport high school, as a result of a criminal operation. Dr. Fabian Pratt and Dr. Jacob Hall are held on a second degree charge of manslaughter.

Prohibition of dances and social entertainments, except under the chaperonage of instructors, is urged today as a result of the tragedy. The case also is expected to result in the introduction of sex hygiene into the school curriculum. Sixteen boys are involved in the Zook case. Prosecutor Jacobs says he is determined to punish the guilty party.

### EDNA GOODRICH TO WED ENGLISH DUKE

NEW YORK, Aug. 7.—Edna Goodrich, one of Nat Goodwin's former wives, is in New York today after a three months' trip abroad, during which time, she says, she became engaged to an English duke. The actress refused to reveal his name, explaining that the engagement had not been formally announced.

### TRAVELS 5000 MILES TO WED HER LOVER

SAN FRANCISCO, Cal., Aug. 7.—Traveling 5000 miles from Shanghai because she wants to wed W. A. Eshagen, a traveling auditor for the Standard Oil company, and willing to travel 3000 more to attain her end, Miss Wynne Campbell arrived here today on the liner Shinyo Maru.

Miss Campbell made the journey to ask permission of her parents to marry Eshagen, and if they consent will leave shortly for New York to become Mrs. Eshagen. The young woman met Eshagen while she was employed as a stenographer in the Standard Oil offices at Shanghai.

### GARRISON INSPECTS ABANDONED POST

WALLA WALLA, Wash., Aug. 7.—Spurning the automobiles which were waiting at the train, Secretary of War Garrison, Major General Wood and party who arrived this morning, walked six blocks to the hotel for breakfast. Escorted by a committee from the Commercial club the war secretary and General Wood inspected the abandoned post here but would not say whether or not the post would be re-garrisoned.
