CRAIG ON TRIAL FOR MURDER OF WOMAN DOCTOR

SHELBYVILLE, Ind., Oct. 23.—Exactly two years ago from the day Dr. Helene Knabe, the state's leading woman doctor, was found almost nude in her apartments in Indianapolis with her head nearly severed at the neck, Dr. William B. Craig, her most intimate friend, was today placed on trial here for her murder. The case came to this county here on a change of venue. In alleged attempts of Dr. Craig to end a relationship with Dr. Knabe that had become objectionable to him and had caused bitter quarrels between them, the state claims to have a motive for the murder, October 23, 1911. Evidence will be introduced to show that Dr. Craig knew of the murder before any one else. His housekeeper will testify that he returned home late on the night of the crime and changed clothing completely. It will be charged that the handsome veterinary surgeon broke a promise to marry Dr. Knabe in order to marry Katherine Fleming of Avon, Ind., Indiana's leading criminal attorney figure in the trial. Craig's lawyers are Elliott R. Hooten and Henry Spann of Indianapolis, Assistant Prosecutor Frank P. Baker of Indianapolis are Eph Imman, John Holtzman and William Ketchen, all of Indianapolis.

Hennessy on a criminal libel charge. It was known positively that a rapid exchange of messages was in progress between Tammany Hall, Jerome and District Attorney Whitman's office.

DRUMGOOLE'S FATE RESTS WITH JURY

SACRAMENTO, Cal., Oct. 23.—With the evidence practically completed and the arguments of counsel scheduled for this afternoon's session of court, Jack Drumgoole, a prizefighter formerly of Chicago, charged with the murder of Chery de St. Maurice, a Sacramento resort keeper, will, in all likelihood, know his fate before nightfall.
 The introduction, as part of the evidence, of a confession made by Drumgoole following his arrest in San Diego, was desperately fought by Attorney Tuttle, representing Drumgoole, but Judge Conley ruled that the confession was admissible and it was read into the record. Tuttle contended that the statement was secured under duress, as a result of "third degree methods," and maintained that his client had since repudiated it.
 Testifying in his own behalf, Drumgoole swore that Haber choked the woman to death and denied that he had committed the crime, as charged by Haber.

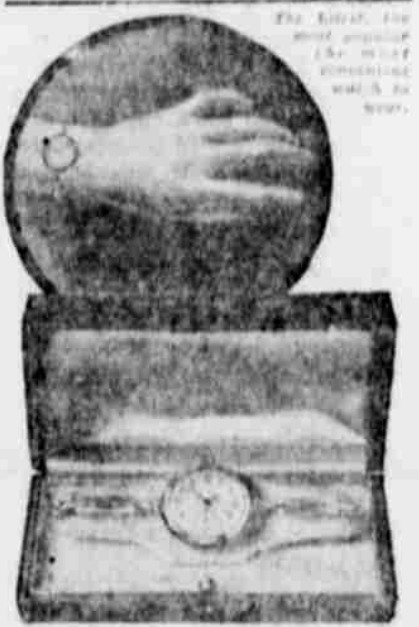
