

### SPENCER CALLS JUDGE BIGGEST FOOL IN COURT

WHEATON, Ill., Nov. 12.—Attorney Zemon, representing Henry Spencer, on trial here for the murder of Mrs. Mildred Allison-Rexroat, was knocked down at the opening of court today by his client.

"I am damned tired of this delay," shouted Spencer, flooring him. Sheriff Kuhn and two deputies overpowered Spencer.

Court attaches were unable to quiet Spencer.

"I don't need an attorney," he shouted. "You pinheads are simply wasting time. The judge here is the biggest fool in the courtroom. He has about as much brains as a sack of sawdust."

"I committed every one of the crimes published in the newspapers. I killed Mrs. Rexroat and then drank her blood. Why don't you fathens strike me up and have it over with?"

The jury which is to try Spencer was completed at noon. Shortly before the twelfth juror was accepted, Spencer turned to the court and said:

"If you were not so narrow between the eyes you would have a woman foreman put in charge of that jury, and then we could get started in a hurry."
