BIRD OF PARADISE HERE ON FRIDAY

The first play of "America outside America" to ring true and strike a note of deep and lasting philosophy is Richard Walton Tully's "The Bird of Paradise," which Oliver Morosco is to present here, in its original sumptuous production, at the Page Friday evening, Nov. 14. "The Bird of Paradise" is a story of modern Hawaii, and, in brief, might be termed a splendid satire on the futility of attempting to reverse the anti-civilization of ten thousand years in a score of years, or to turn back the hot surf of the indolent tropics with the icy currents of the north. Tully has told his story with unflinching interest. From the time the lovely, half-made Luana drops her melting eyes upon the handsome young American; from the time the American girl sees the shabby, shambling, south sea dervish in his bamboo jungle by the coral-bound wavelets, there is rushing action, pulsing emotion, genuinely throbbing humanity. As a play of absolute originality this piece held New York spellbound; it cannot be otherwise wherever presented.

EIGHTEEN PERISH GEORGIA WRECK

MONTGOMERY, Ala., Nov. 13.—At least 18 persons were killed and more than 200 injured today when a Georgia Central passenger train crashed through a trestle near Clayton. Three cars were smashed to kindling wood and hardly a passenger in any of them escaped broken bones. Relief trains were rushed to the scene. The accident, according to this afternoon's accounts, was much worse than earlier reports indicated. The train was carrying a big excursion party.
