The annual report of the Oregon Railway and Navigation Company shows the total expense account for the year to be about \$5,000,000.

The O. R. & N. Co.'s stock is the only one of the Villard stocks that sells at par; it is the only one that is looked upon as a present paying investment.

So that the controlling interest in the two companies had not cost Mr. Villard and friends a great deal of money. He then made up his famous combination, and organizing the Oregon Railway and Navigation Company by consolidating the two old companies, he, in 1880, floated \$12,000,000 of stock and bonds of the new company.
