NOTICE OF ELECTION.

Palestine, Texas, Aug. 3, 1910.
To the Property Tax-Payers of Palestine:

We have this day passed an ordinance calling on the property tax-payers to vote on two propositions, one to issue \$17,000 in bonds to pay for and improve two public parks in the city of Palestine, one of about 22 acres to be purchased out of what is known as the Michaux Grove, to cost \$12,000, the other in the northern part of the city, bounded on the south by Cherokee street, on the west by Conrad street, on the east by Queen street, and on the north of Alkire's Line, containing about 20 acres, for \$3,000; also \$2,000 to improve the parks (one thousand dollars each). And a second proposition to ask the property tax-payers to vote on a bond issue of \$9,000 to buy fire fighting equipment. At the present time we have but very little fire fighting equipment, and will have to purchase some as soon as possible, if we hope to reduce or even maintain our present insurance rates.

We desire to advise you that the issuance of these bonds will not in any way increase your present tax rate or cause you to pay any more taxes than you will pay if they are not issued. They will be taken care of in the 25c bond levy for public improvements that is fixed by law and cannot be increased, but is always levied to care for bonds. We now have room in this fund to take care of these bonds without increasing the tax rate.

AN ORDINANCE

Providing for the holding of an election in the City of Palestine, Texas, to determine:

First. Whether or not the City Council of the said City shall be authorized to issue bonds of the said City in the sum of \$17,000.00 for the purpose of purchasing and acquiring lands for public parks, consisting of about twenty-two acres in what is known as the Michaux Addition to said City, and of about twenty acres lying in the northern part of said City, immediately adjoining and north of Green's North Hill Addition to said City, and for the improvement of such lands for public park purposes.

Second. Whether or not the City Council of said City shall be authorized to issue bonds of the said City of Palestine, in the sum of \$9,000.00 for the purpose of purchasing and acquiring new fire equipment and apparatus for the use of the said City of Palestine by its fire department, and in fighting and protecting said City, its inhabitants and property from fires.

And fixing the date for the holding of said election, the rate of interest which said bonds shall bear, and the date of their maturity, designating the voting places for the several wards of said City at which said election shall be held and for the appointment of the presiding officers and judges of the several ward voting precincts in said city to hold such election, prescribing the form of official ballot to be used at such election, and who shall be permitted to vote on said questions at said election, and for notice of such election to be given to the voters of the several wards of said City.

Be it Ordained by the City Council of the City of Palestine:

Section 1. That an election shall be held in the City of Palestine, Texas, on Tuesday, the Sixth day of September, 1910, for the purpose of submitting to the property tax-paying voters of the said City of Palestine the following propositions, to-wit:

First. Shall the City Council of the City of Palestine, Texas, be authorized to issue bonds of the City of Palestine, in the sum of \$17,000.00 for the purpose of purchasing and acquiring lands for Public Parks consisting of about 22 acres in what is known as the Michaux Addition to said City, and about 20 acres lying in the northern part of said City, immediately adjoining and north of Green's North Hill Addition to said City, and for the improvement thereof, for public park purposes?

Second. Shall the City Council of the City of Palestine, Texas, be authorized to issue bonds of the said City in the sum of \$9,000.00 for the purpose of purchasing and acquiring fire equipment and apparatus for the use of the said City of Palestine by its fire department and in fighting

and protecting said City, its inhabitants and property from fires?

Section 2. Each series of said bonds to be dated October 1st, 1910, to become due and payable forty (40) years from their date, shall bear interest at the rate of five per cent (5 per cent) per annum from the date of their issuance until paid, the interest thereon payable semi-annually at the office of the City Secretary of the City of Palestine, at Palestine, Texas, or at the National Park Bank, in the City of New York, or at the Austin National Bank, at Austin, Texas, at the option of the holder or holders of said bonds, and to be made redeemable at the option of the City of Palestine at any time after ten (10) years from their date.

Section 3. Said election shall be held in each of the four wards of the said City of Palestine, each of such wards being hereby designated and constituted an election precinct for such election and the voting places for said election in the various election precincts herein named with the presiding officers of each election precinct and voting places, shall be as follows:

Election Precinct No. One, 1st Ward, voting place shall be at the Court House of Anderson county, Texas, with J. D. Moore as presiding officer, and J. E. Rose and R. J. Wallace and S. V. Knighten as assistant judges of said election.

Election Precinct No. Two, 2nd Ward, voting place shall be at the Recorder's Office in the City of Palestine, with J. D. Frederick as presiding officer and J. F. Brown and W. H. Briggs and L. J. Berryman as assistant judges of said election.

Election Precinct No. Three, 3rd Ward, the voting place shall be at the Railroad Y. M. C. A. Building, with Chas. Jacobs as presiding officer and S. E. Reed and F. D. Gilliam and Jas. Healy as assistant judges of said election.

Election Precinct No. Four, 4th Ward, the voting place shall be at the office of the Palestine Electric & Ice Company, with S. A. Taylor as presiding officer and W. B. Davis, E. A. Williamson and Will Lyne as assistant judges of said election.

And the presiding officer at such election, hereinabove named, shall select and choose the necessary clerks for holding said election, as required by law, and in case of the failure or refusal of either of said presiding officers or judges named to preside over and conduct said election, it shall be the duty of the Mayor to appoint some other qualified person to conduct said election, and in the event of the failure of either of said presiding officers or judges herein appointed, to act, or the Mayor to appoint some qualified person to conduct said election, the officers of such election shall be chosen and selected as provided by the laws governing the holding of general elections.

Section 4. That said election shall be held under the provisions of Chapter 146 of the Acts of the 26th Legislature, and any amendments thereof, and only qualified voters who are property tax-payers in the City of Palestine, Texas, shall be allowed to vote at such election.

Section 5. All voters desiring to vote in favor of authorizing the City Council to issue \$17,000.00 in bonds for the purpose of purchasing and acquiring lands for public parks, as hereinabove mentioned, and for the improvement thereof, shall have written or printed on their ballots "FOR the issuance of \$17,000.00 in bonds for the purpose of purchasing and acquiring lands for public parks, consisting of about 22 acres in what is known as

the Michaux Addition to the City of Palestine, and of about 20 acres lying in the northern part of the City and adjoining Green's North Hill Addition to the City of Palestine and for the improvement thereof for public park purposes." And all voters desiring to vote against authorizing the City Council to issue said \$17,000.00 in bonds shall have written or printed on their ballots "AGAINST the issuance of \$17,000.00 in bonds for the purpose of purchasing and acquiring lands for public parks, consisting of about 22 acres of what is known as the Michaux Addition to the City of Palestine and of about 20 acres lying in the northern part of the City of Palestine, and adjoining Green's North Hill Addition to the City of Palestine, and for the improvement thereof for public park purposes."

All voters desiring to vote in favor of authorizing the City Council to issue bonds in the sum of \$9,000.00 for the purpose of purchasing and acquiring New Fire Equipment and apparatus for the use of the said City of Palestine, by its Fire Department, and in fighting and protecting said City, its inhabitants and property from fires, as hereinabove mentioned, shall have written or printed on their ballots "FOR the issuance of \$9,000.00 in bonds for the purpose of purchasing and acquiring new fire equipment and apparatus for the use of the said City of Palestine, by its Fire Department, and in fighting and protecting said City, its inhabitants and property from fires." And all voters desiring to vote against authorizing the City Council to issue said \$9,000.00 in bonds shall have written or printed on their ballots "AGAINST the issuance of \$9,000.00 in bonds for the purpose of purchasing and acquiring new Fire Equipment and apparatus for the use of the said City of Palestine, by its Fire Department, and in fighting and protecting said City, its inhabitants and property from fires."

Section 6. Each of said propositions for the issuance of bonds as herein set forth shall be voted upon as separate and distinct from each other, and the acceptance or a majority vote in favor of one of said propositions, by the voters at said election, shall not be construed as an acceptance or vote in favor of the one which may be rejected or voted against by a majority of the voters, nor shall the rejection or a majority vote against one of said propositions be construed or operate as a rejection or vote against the one which may be accepted or voted in favor of by a majority of the voters of said election. But the vote on both propositions shall be written or printed on one and the same ballot cast by each voter.

Section 7. Said election shall be held in the manner provided by the laws of the State of Texas, regulating the holding of general elections, except that none but property tax-payers in the City of Palestine shall be permitted to vote at such election.

Section 8. A copy of this ordinance, signed by the Mayor of the City of Palestine, shall be sufficient and proper notice of the holding of such election, and the Mayor of the City shall cause said notice to be posted up at each of the voting places herein designated for said election and shall cause the same to be published in a newspaper in the City of Palestine for a period of thirty (30) days prior to the holding of such election.

Section 9. That this ordinance take effect and be enforced from and after its passage.

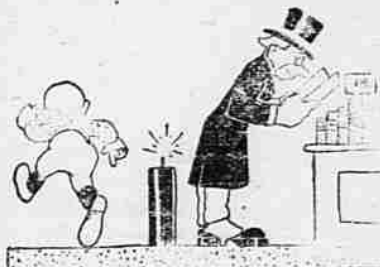
