### Entrenched for Battle, They Hold the Properties They Refuse to Work.

ARE ASKING FOR A WAGE INCREASE

Bingham, Utah, Sept. 19.—A foreign army, fortified and determined, held undisputed possession of the copper, lead and silver mines of Bingham when the second day of the miners' strike for a 35-cent increase in pay and recognition of their union dawned.

Efforts to open communication with the entrenched Greek miners this afternoon failed, as newspaper men who started up the hill toward them were stopped by bullets. John Stanopoulos, supposed to be one of the commanders of the garrison, attempted to negotiate for the entire supply of guns in the Bingham general store.

### Threat of Open Battle.

The chief deputy in charge had at that hour threatened to storm the miners' stronghold on the mountain side. It was that again and again in messages to congress and in speech after speech when I was president. ### NIJARAGUANS FORCE REBELS TO RETREAT

### Insurgents Open Fire on Troop Train of American Marines, but Cars Are Backed Out of Range of Guns.

Managua, Nicaragua, Sept. 19.—(Sunday)—Via San Juan del Sur, Sept. 19.—(Delayed in transmission)—For the last three days the Nicaraguan government forces have been attacking Masaya, the southern headquarters of the revolutionary army, about 20 miles from the capital. The troops succeeded in reaching the outskirts of the city, forcing the rebels to retreat to the fortress on Barranca hill.

### LOWER INSURANCE RATES ARE ADOPTED

### Twenty Amendments to General Basis Schedule on Dwellings and Stores Effective Friday.

Austin, Texas, Sept. 19.—Twenty additional amendments to the general basis schedule of insurance were adopted today by the state insurance board applying on dwellings and stores and castles risks. All of these amendments provide for reductions in the present insurance rates, varying from 10 to 25 per cent from the present rates. These amendments become effective tomorrow.
