The Egyptian Question.

Special to the Gazette. LONDON, April 12.—A. C. Morton, member of parliament, for Peterborough, remains today the man of the hour. The speaker prevented him from putting just previous to the recess, as to the connection between the Newfoundland fishery and the English occupation of Egypt. The idea of any relationship between the two matters may seem a far-fetched one; but there is undoubtedly a widespread notion among members which the government will not have to work to dispel. That fisheries question is simply a pawn on the general diplomatic chess-board. They think that were relations between England and France severed, the only solution France would see was to have out of England's treaty rights, but that the French government is giving Britain in Newfoundland a quid pro quo for what they have done in regard to other questions concerning which the interests of the two countries have clashed. It is this idea which is at the bottom of the exasperation which the Newfoundlanders display and although Morton is not likely to get any answer to his question, which will disturb their minds on this point, it is advisable that this aspect of the matter should be brought to the notice of the house of commons. Meanwhile, there are solid grounds for believing that the whole question is causing the gravest anxiety at the British foreign office. At present the government is far from seeing its way out of the difficulty.

Crops Almost Uniformly Reported to be in a Flourishing Condition. The Season Late, but the Conditions Are All the Finer.

The other counties report a decrease in acreage in wheat and oats, and a decrease in corn acreage. The report shows a decrease in acreage in wheat of 60 per cent, and in corn of 60 per cent. Out of the seventy-five counties, eight report the same acreage as last year in one or more crops. Of these eight counties, two report the same acreage in two crops, viz., Dallas county in wheat and oats and Falls county in corn and oats. Of the other counties reporting the same acreage, Falls county in wheat and Henderson county in wheat report the same wheat acreage.
