MISS MARTHA BOWERS THROWN FROM HER HORSE

Sustained Double Fracture of Right Arm—Was Out Riding With Miss Helen Taft

Washington, Jan. 28.—While horseback riding late today with Miss Helen Taft, daughter of the president, and two other companions, Miss Martha Bowers, daughter of the late Solicitor General Lloyd Bowers, was thrown from her mount and had her right arm broken, when her horse was instantly killed by collision with a street car. Miss Taft and the others escaped injury.

The party was riding down a steep hill when Miss Bowers' horse became unmanageable and dashed away at breakneck speed. The others followed but could not overtake her. At the foot of the hill, which was in the fashionable part of the city, the horse ran into a street car, throwing Miss Bowers violently to the pavement. A moment later Miss Taft and other members of the party, which included Miss Isabel Bincent of Minneapolis, a guest of Miss Taft at the White House, and Dr. Cary T. Grayson, past assistant surgeon in the navy and naval aide to the president, reached Miss Bowers' side.

Aided by Miss Taft, Miss Bowers was carried to a nearby physician's office where she was given first aid treatment. Later it was decided to remove her to a hospital.

Miss Taft immediately telephoned for the White House automobile and rode to the hospital with Miss Bowers. The president's daughter saw to it that everything possible was done to relieve the suffering of her friend

Physicians made careful examination found that in addition to a double fracture of the right arm, she sustained lacerations of the scalp and bruises about the body.

JAIL TERMS FOR THIRTY SUFFRABETTES

They Refuse Option of Paying Fines and Go to Prison

Lodon, Jan. 29.—"General" Mrs. Drummond and thirty other militant suffragettes will spend the next four teen days in jail as the result of their determination to force David Lloyd George, chancellor of the exchequer, to receive them in the House of Commons last evening.

All the prisoners declared after they were sentenced today that they would start a "hunger strike." The accused women were brought up at Bow street police court before Robert Marshall, police magistrate.

Mrs. Drummond complained during the hearing that the police had handled her roughly, when she was arrested. She declared a patrolman had thrown her in the mud.

"It is now war to the knife," she told the magistrate and continued: "You and Mr. Lloyd George have a lot of trouble ahead of you. You will have to do the dirty work and you will have plenty of it."

The women all refused the option of paying fine instead of going to prison.

Bow street police court looked like a busy railroad station when the suffragettes were arraigned. Most of the women had made preparations to go to prison. They carried boxes, bags, blankets and fur lined coats.
