## POLICE LEARN NAME OF OTHER OGDEN ROBBER

**Captured Drug Store Bandit Said to Bear Cognomen of King**  
**DESCRIPTION GIVEN OF MAN WITH LOOT**  
**Peace Officers Hope to Get Hurried Action on Prosecution of Prisoner**

Identify the robber who escaped yesterday morning after robbing the depot drug store of \$521, has been established, according to information received from the police station. Harry Byars, the burglar who was captured, said he knew his partner under the name of King. The following initials were used by King, according to Byars: W. L. J. E. C. L. and L. C. King was described as a man 25 years old, wearing a pair of blue overalls, a blue jumper, grey cap and red sweater.

**DESCRIPTION OF ROBBER.**  
He had blue eyes, brown hair and weighed from 120 to 125 pounds. His height was given by Byars as about five feet eight inches.  
On his cap the man wore a small B. of E. T. button, and was either a switchman or a trainman.  
Byars is confident regarding the robbery, the police report, but feels that he has been made the "head" by his partner. The men had no prepared plans for making their escape, and Byars feels that if he had accompanied his partner, that both of them would have escaped.

Telegrams were sent by the police in every direction and nearby towns and cities have been notified of the robbery. It is the belief of the police that King will be captured within a short time.

**PROSECUTION.**  
Police hope to press the prosecution of Byars on a criminal charge with a view to making his rapid conviction a warning to others who have a hand in a life of crime.

There was much comment today on the similarity of the robbery yesterday to the robbery of Seth Thomas store a month ago.  
When robbers entered the Thomas store, Thomas shot and killed one bandit who was holding the pistol, while the other got away with a tray of doughnuts.

In the case of the depot drug store robbery the man with the \$521 in the cash box escaped while his partner, who was the man with the gun, was caught.

## PANAMA PRESIDENT ELECT ACCUSED OF VOTE FRAUD

PANAMA, Dec. 24.—The Nicaraguan legation at Panama today gave out a message from the Managua, foreign office stating that the national congress has declared Diego Manuel Chamorro and Bartolo Martinez, constitutionally elected president and vice president, respectively, of Nicaragua. The new executives are to take office January 1.

Announcement was made in Managua recently that supporters of Jose Andres Urtiaga, former minister of foreign relations, who was defeated in the presidential election by General Chamorro, had appealed to the state department in Washington to take some action regarding the election, as setting that flagrant frauds were committed. They were said to be supported by many influential members of the conservative party.

## CARDINAL BRIGHTENS UP AFTER CHRISTMAS MASS

BALTIMORE, Md., Dec. 25.—Encouraging news concerning the health of Cardinal Gibbons was received today from the home of Robert T. Shriver, at Union Mills, Maryland, where the venerable cardinal has been a guest for several weeks. A midnight mass was said in his room by his secretary, members of the family of his host also attending.

The cardinal was reported as having rested well after the service and as feeling "very bright" this morning. It was also stated that the prelate has been showing improvement for the last few days.

**WASHINGTON, Dec. 25.**—President Wilson planned to spend his last Christmas in the White House quietly today. The president and Mrs. Wilson, however, were expected to be in the White House for the holiday season, formed the family circle for the simple Christmas dinner arranged.

**OLD SANTA GOOD TO HARDING.**

There were literally hundreds of them, ranging from cigars to Georgia "possums." Not a single present was opened until this morning.

**DISABLED SOLDIERS REMEMBERED.**  
NEW YORK, Dec. 25.—New York's "green Christmas" was marked by unusual activities on the part of charitable organizations to bring cheer into the hearts of the unfortunate, who are patients in many hospitals, and recipients of mountain gifts and special dinners. The Salvation Army, the Elks, Knights of Columbus and other fraternal societies distributed dinners and gifts to the poor. Thousands of immigrants, held up for the day aboard ship at Ellis Island were given a sample of American hospitality.

Employees of the Todd Shipyards corporation assessed 10 per cent of their wages to provide clothing for 3000 poor children. Various societies banded together to provide cheer to the thousands of patients in city hospitals.

Midnight masses in Catholic churches were unusually well attended. At the church of St. Rose of Lima, a mass written in 1745 was sung for the first time in America.

These were not of madras today in the services at the Protestant Episcopal cathedral of St. John the Divine, where the late Bishop Charles Sumner Burleigh was to have presided.

The community Christmas tree in Madison square—lighted by 5000 electric candles—attracted an immense crowd last night, and carols were sung by a great chorus.

Sunday school children visited Trinity cemetery and placed wreaths on the graves of Clement Moore, author of "Twas the Night Before Christmas," and of Alfred Tennyson, Dickens, son of Charles Dickens.

**CARDINAL MERCIER SENDS GREETINGS.**  
NEW YORK, Dec. 25.—Christmas greetings from Cardinal Mercier of Belgium were received here today at the headquarters of the Knights of Columbus.

Cardinal Mercier said support of his countrymen by the Knights of Columbus provided Belgians with a happier Christmas than otherwise could have been. Cardinal Mercier declared that the Knights of Columbus pilgrimages would remain one of the most striking civic memories of his time.

**HOHENZOLLERN CELEBRATE QUIETLY.**  
DOORN, Holland, Dec. 25.—The third Christmas of the Hohenzollern in Holland will be less pretentious than last year's celebration at Amerongen. The serious illness of the former empress and the suicide of Joachim will give the observance more of an air of mourning than celebration.

Many messages of greeting have been received at Doorn where the Duchess of Brunswick and the former Crown Prince Frederick Wilhelm will stay with their parents until after New Year.

The ban on cosmetics which has been enforced for years was abolished today at the suggestion of the students of the Elmira high school, who desired to make the inmates Christmas gifts of face powder, rouge, cologne and other toilet accessories.

**TWO HUNDRED PERSONS CLAIM LOST \$5 BILL**  
BERKELEY, Cal., Dec. 25.—A \$5 bill was advertised as found by the Berkeley police department Thursday. In two days 236 persons have claimed ownership, according to Sergeant Charles Becker. None was able to identify the bill to his satisfaction and he still holds it.

**FUMES OVERCOME SEVEN FIREMEN AT TONTO**  
TORONTO, Dec. 24.—Overcome by fumes from burning chemicals, seven firemen were rescued after they had been trapped on a collapsed staircase during a fire in the building of the E. B. Shuttleworth Chemical company here tonight. The blaze entailed a loss of \$250,000.

## CHILEAN WINE GROWERS FIGHT DRY MOVEMENT

**Government to Lose Great Income Should Prohibition Go Into Effect**  
SANTIAGO, Chile, Dec. 24.—One of the first official acts of President Arturo Alessandri, who assumed office on Thursday, was to receive a petition from a Chilean Federation of Labor protesting against the alleged creation of the League of Defense of the Wine Industry to force northern port workers to unload liquor. The labor organization already had adopted a resolution to refuse to unload liquor, whether of home or foreign manufacture.

In defending the wine industry, Senator Edwards declared a real "taxation" in developing this country against alcohol and wine. He asserted the importation of alcohol and its sale at bars could be prohibited but that it was not advisable to adopt measures which would "ruin a national industry, prejudice workers in this line of employment and force a transformation of industry."

**LEAKING GAS SMOTHERS NEWLY WEDDED COUPLE**  
NEWARK, N. J., Dec. 25.—A small, dark-eyed girl, who arrived here Thursday from Naples, Italy, and her husband, Edoardo Brullo, whose wife she became a few hours later, were found dead from asphyxiation Friday in their snug Academy avenue apartment. A month ago in Italy Carmella received money for steamship fare and with it a note: "Come to me, my sweetheart, and we will be married at Christmas time."

**THREE U. S. PRISONERS PARDONED BY WILSON**  
WASHINGTON, Dec. 25.—Three pardons, as President Wilson's Christmas list to men serving sentences in federal prisons, were announced by the department of justice. They were Clarence Brown, serving a life term for murder at Atlanta, Rufus Casselbury, serving a life term at Leavenworth, and Edward C. Rivers, serving two years at the United States penitentiary at McNeil Island, Washington, for violation of the narcotic laws.

## GOODFELLOWS OF OGDEN MAKE KIDDIES HAPPY

**If Any Families Are Overlooked There Are Toys Left for Them**  
**MANY DISTRESSING CASES FOUND BY INVESTIGATORS**  
**Scores of Charitably Inclined Persons Assist in Making Happy Homes**

More than 500 children of 120 Ogdens families were made happy, Christmas cheer, including food, toys, games, dolls and clothing by the Good Fellows this morning, the greatest number ever supplied by that organization. Working for four hours on Christmas eve a dozen Good Fellows arranged the articles for distribution, dividing them according to the needs as reported by special investigators.

Before daylight this morning the Ogdens Standard-Examiner offices were a beehive of industry when fifty Boy Scouts, a half dozen scoutmasters and a number of other Good Fellows started the loading of eight automobiles and trucks, donated and driven by other Good Fellows. These motor cars travelled through the city streets taking the packages and boxes to the many homes to which Christmas cheer would not have come otherwise.

**ALL KINDS OF DOBBS.**  
There were all kinds of things that walked, those that closed their eyes, the unbreakable kid, the kid body style, the little baby dolls and little sister dolls—in fact, every kind of doll that could be secured. There were tables and children's tables, sleds, wagons, baseballs, games, knives, aluminum sets, books, tops and a hundred other kinds of amusing gifts made up the assortment. Besides these, there were nuts, oranges and candies, flour, pork and beans, peas, tomatoes, meat and other provisions. Stockings, underwear, shoes, coats, covers, overalls and other wearing apparel was in the lot. Gifts that were made in the manual training department of the Lewis and Clark high school, the high schools were among the articles distributed. The classes of other schools had also made similar articles which were distributed to the poor by other charitable organizations.

**MADE AT SCHOOL.**  
These articles made at the schools were among the most substantial that were distributed and proved welcome gifts among the little folks.

Not one family of those reported to the Good Fellows was neglected and many of the Santa Claus letters were answered. Gifts were distributed being given to every one in which investigators had found need.

In several instances it was found that families were in direct distress and there was a lack of necessities of provisions and clothing left. These cases will be reported to the county officials in order that further help may be possible.

**GENEROUS ASSISTANCE.**  
The Good Fellows received this year the most generous assistance of many manufacturers, distributors and professional men, as well as women in other walks of life. Hundreds of dollars' worth of articles were generously donated, both by the makers and by the store owners. In other instances extremely liberal discounts, even to 50 per cent of the cost price, were given. Some gave both goods and money. The greatest help was the heaviest contributor to the fund, providing slightly less than half of the money that was used.

**MUCH DISTRESS FOUND.**  
Investigations by the Good Fellows have shown that there is much distress in the city this year, considerably more than last year, when similar work was done by the organization. Several of the Good Fellows who made investigations on the eve of Christmas found this distress so serious that they spent large sums in aiding families, one of the Good Fellows aiding three families and buying shoes, underclothing, stockings, food and other articles for all of the children.

The Good Fellow work was materially assisted this year by the Boy Scout organization, both as to investigations made by the scoutmasters and the distribution work in which the scoutmasters and the Boy Scouts themselves aided.
