Yale & Bowling vs. Leander B. Haworth et als; judgment reversed—the plaintiffs to have judgment against defendant, Jeannette Rosenthal, wife of Jonas Rosenthal for \$350 with interest from first day of December 1883 until paid, and for \$14.30 costs of protest, also to pay costs in both Courts.

Jas. A. Renshaw vs. S. A. and Mrs. A. C. Dowty; judgment of the lower Court affirmed at appellant's oost; rehearing refused.

John F. Kelly vs. New Orleans

& Pacific Railroad Co., judgment reversed, and plaintiff to pay costs of both Courts.
