The Changes in His Favor and a Possibility That He May Recover, NEW YORK, April 10.-Ex-Senator Conking rested quietly from the time the surgeons left him at 2:40 o'clock this afternoon until 4:30 o'clock when he began to get very estless. At 5:06 Dr. Barker called and re mained until 5:35. Up to the time of his arrival the patiers had restlessly paced the room and the attendants could do nothing with him. He refused all medicine and they could not force it into his mouth. When the doctor arrived Mr. Conkling recognized him and said: "Doctor, can't you do anything to stop this bothering me?" "Why certainly, replied the doctor, "take this medicine. Mr. Cohkling took it readily from the doc tor's hand and then said: "Can't I go out? I'm very busy." Again the doctor answered: "Certainly," adding, "Take these pills first." He then administered some pills which speedily produced sleep. Mr. Conkling, to whom the doctor had handed his coat and vest, had partially dressed himself, but now fell back on the bed and into a deep slumber. At 5:45 his pulse was 90, temperature 100 1-5 and respiration 25. After a forty minutes nap he awoke apparently in better condition than at any time since his illness.
