FIRST SUGAR TEST VOTE

House Democrats in Caucus Down Anti-Schedule Amendment.

Washington, April 12.—By an overwhelming majority the house Democrat caucus today voted down amendment to the sugar tariff schedule proposed by Representative Broussard of Louisiana and supported by members from the sugar states to climinate the provision for free sugar in three years and provide an immediate ten per cent reduction to be followed by gradual reduction for six years. The vote against it was 86 to 15. "If we cannot get votes enough in the caucus," said Representative Adair of Indiana, "we will exempt ourselves from the caucus pledge and fight on the floor hoping for enough Republican alliance against free wool to carry our points."

The first sugar amendment in the caucus was by Representative Hardwick to make sugar free on May 1, 1916, instead of June 30 that year as provided. He said he wanted housewives to get the benfit of the reduction in the canning season. He offered another providing flatly free sugar on the passage of the bill. Representative Broussard offered an amendment for a ten per cent reduction only. The caucus also rejected 105 to 45 another amendment by Representative Broussard proposing to extend to four years the method of grace before sugar should become free.
