MAY PROSECUTE

MRS. ATCHERLEY

Libel May Be Charged For Sending Out Circulars

If it is decided by the Attorney General of the Territory that the circulars which were distributed by Mrs. Atcherley yesterday calling a mass meeting of Hawaiians, contained directly libelous charges against Dr. Sinclair and Brinckerhoff, the author will be prosecuted to the full extent of the law. Mrs. Atcherley refers to the two well-known M. D.'s as "limb-choppers" and speaks of them in other terms that could not be exactly called compliments.

The general impression seems to be that if some summary action, such as the above were instituted, it would effectually put a stop to all the complaints from Hawaiians who really do not understand the true condition of affairs, but who take the word of Mrs. Atcherley and her followers.

WRESTLER SPENCER CHARGED WITH FRAUD

James O. Spencer, the well-known Hawaiian wrestler, this morning had two charges of gross cheat placed against his name at the police station. He is alleged to have passed a couple of bad checks, both on the First National Bank. One of these, for the amount of \$4.85, he gave to Peter of the messenger service, tendering it in payment of a debt of \$1.85 and getting \$3 in change. This he is alleged to have signed with the firm name of Crane & Spencer, of which he was some time ago a member, by J. O. Spencer. The other check, for \$2.50, he is alleged to have given the Union Grill, signing it with his own name.



WATERFRONT NOTES

CUTTER FOR HONOLULU.

In case the gunboat Vicksburg is transferred to the Revenue Cutter Service, a cutter will undoubtedly be sent permanently to Hawaiian waters, according to a letter from Beekman Winthrop, Acting Secretary of the Treasury Department, to H. P. Wood, secretary of the Chamber of Commerce. No action can be taken, however, before November 1st, when the fleet of revenue cutters returns from the Behring Sea to the Coast.

MONGOLIA LOADED.

The Mongolia sailed from Yokohama yesterday for this port, with 600 tons of freight to be unloaded here. She is due to arrive on the 28th, and will sail on the same day for San Francisco in case she arrives early in the morning, giving time for the discharge of the 600 tons of freight which she brings. She has room for 125 cabin passengers for this place.

A-H. SAILING DATES.

The next sailing dates from the Coast for American-Hawaiian steamers are the 26th, when the Texas leaves San Francisco for Honolulu, and the 30th, when the Alaskan sails for this place from the Sound.

THE KE AU HOU arrived early today from Kauai ports, after being delayed three hours by a defective boiler tube. She had three deck passengers and cargo as follows: 312 bags rice, 488 bags paddy, 3 trunks, 1 crate chickens, 4 bags ginger, and 25 packages sundries.

THE DIX has now unloaded about 2000 tons of the 5300 tons of coal which she is to put out here. It is expected that she will get away for Seattle with 2700 tons of her cargo still under hatches some time in the first part of next week.

THE ASIA is due here from the Orient on Saturday. She has 420 tons of general freight for this place. The China will be the next Pacific Mail arrival from the Coast, coming in on Monday if she is on schedule time.

THE DIPPER dredge came off the marine railway this noon. The big machine has been undergoing an overhauling for some time past.

THE HELENE brought in 75 head of cattle and 50 head calves this morning from Hawaii.
