

BOY COMES BACK WITH \$6,500 HE DREW FROM BANK

Sapperstein Couldn't Get Rid of Big Bills He Got at Knickerbocker.

Philip Sapperstein, a seventeen-year-old messenger-boy, who failed to return to the Day and Night Bank after collecting \$6,500 from the Knickerbocker Trust Company during the past yesterday, gave himself up in the office of the American District Telegraph Company, Fifth Avenue and Forty-first street, shortly after 1 o'clock this afternoon.

"Well, here's that money," said the pale-faced, deep-eyed youth, as he strode into the office. "I spent all last evening and all morning trying to cash one of these bills, but it was no go. What use are they to me when I can't get anything on 'em? Take them. I want to go back to work."

Detectives quickly grabbed the boy and then telephoned the bank. Sapperstein is a weakly built, blond-haired boy. He was dressed shabbily. He has none of the marks of shrewdness and alertness common to the messenger, and seemed rather indifferent to the consequences of his theft when taken to headquarters.

COMMODORE PARK, OF A.Y.C., DIES IN A HOSPITAL

Enthusiastic Yachtsman and Well-Known Philanthropist Passes Away.

Commodore Trevor L. Park, of the American Yacht Club, Vice-President of the American Trading Company and one of the most prominent sportsmen in New York, died today at the New York Hospital after a prolonged illness. Commodore Park leaves a widow and two children, who have spent much of the last two months at his bedside.

For years the yachts bearing Commodore Park's colors have been in the van of racing hereabouts, his trim three-toners, Miss America and several others, some time ago. The English, which cost \$30,000 almost twenty years ago, one of the first auxiliary steam yachts to go into racing about New York. The Minotaur, of the American Yacht Club, carried his colors successfully in Mashes Bay Yacht Club affairs.

Mr. Park was one of the members of the firm of Cantin & Co. and immensely wealthy. His beautiful new home at Bryn Mawr three years ago, cost more than \$100,000. It is, and still the former residence in White Plains, he and Mrs. Park entertained extensively. The White Plains grounds frequently opened to social gatherings of the most prominent people participated.

At the time of his death the real estate holdings included great portions of the Hudsonack meadows, in New Jersey, and a small interest in the Emma Mine in Utah.
