Green was a cotton-broker in Columbus and an agent for the White S ar line, a combination of freight-carriers engaged in the transportation of cotton from Mississippi to the Eastern States. It it is alleged that about two years ago he swindled certain Fail River manufacturers and several merchants and brokers in Nex-York out of nearly \$200,000, by means of forged bills of lading and forged orders. He left Columbus in April. 1882. A day or two before his departure, Mr. Humphries, who represented several of his creditors, succeeded in obtaining \$20,000 from him and a promise to pay the remainder as soon as he could go to Mobile and get the money. Instead of going to Mobile, he went to Europe and remained there until about a month ago, when he returned to New-York.

ONE DISABLED-THE OTHER SHORT OF MEN. THE SCALIA ABANDONED AND THE MERRYMAN

BROUGHT TO PORT.

The brig F. I. Merryman arrived here yesterday in command of Captain Hoffschild, of the German bark Frederick Scalia, the Scalia's captain having died at sea. Captain Hoftschild abandoned his own vessel, which had been disabled in a hurricane, to take command of the Merryman.

The Frederick Scalia left Stettin on July 11, with

a cargo of salt for Charleston, S. C. She was a bark of 422 tons, built in 1858, and repaired four years ago. Captain Hoffschild, his two mates, . steward and eight men were on board. All went well until September 12, when, without any warning, the bark was caught in a burricane. The wind blew with terrific violence, and great seas swept over the vessel. The hurricane began to blow from the south-southeast and shifted to the southsouthwest. Everything was swept from the decks, boats were stove, sails blown from the bolt-ropes, yards and masts carried away, and a leak started in the hold. When the storm passed away the captain found himself in command of a mastless hull, rolling in the trough of a high sea with the water gaining rapidly in the hold. He set the men to work at the pumps and the leak was stopped as well as it could be under the circumstances. A jury fore-mast was rigged up and a couple of sails bent on, so that the captain was able to keep the vessel before the wind. By keeping the pumps going constantly, the water in the hold was prevented from gaining. When the hurricane struck the bark she was] in latitude 29°, longitude 54°, and when the captain had got his jury mast rigged after the storm he ran before the wind toward the south in order to get into the northeast trades and then be picked up by some steamer. The winds continued light and fair, and on the morning of September 21, just as they were approaching the northern limit of the trades, a brig was sighted flying signals of distress. The two vessels were soon near each other, and a necro standing on the quarter deck sang out:

"Lend us provisions and water and a navigator."

"Where is the captain?" said Captain Hoffschild.

"Dead!" was the answer.

"The mate!"

"Dead, also."

"Lower away a boat and come for us and we will all come aboard and bring provisions and water," said the captain of the Scalia.

"We can't. Only two of the crew are alive, and one of them is sick."

The captain explained that he had no boats and that the brig must lower its boats. After a little delay a boat from the brig came aft, pulled by the negro who had hailed the wrees of the bark and another negro. Cap'ain Hoffschild took some of his meif and went aboard the other vessel. She proved to be the brig F. I. Merryman, of this port, homeward bound from the West Coast of Africa, with a cargo of hides. She had gone to the African coast with a miscellaneous cargo from Boston, and carried a captain, two mates and a steward in the cabin, and four men before the mast. While lying at Bathurst, on the African coast, the first, mate died of African fever. Shortly before the brig sailed on the homeward voyage one of the crew died of the same disease, and a native African Nickerson and one of the crew were taken down with the Sever. The captain impered along for some time, but finally died. Before the captain's death the mate was taken sick, and after ten days he died. About the same time another member of the crew died. This left the steward, the native African and one white sailor to work the vessel. The steward is a Bernnada negro, and he took command. No one of the three knew anything of navigation, and had the same hurricane that wrecked the Scalia struck the Merryman she would probably have gone to the bottom.
